01. Method of Recruitment to Service

Candidates who obtain the highest marks on the basis of the results of an interview to evaluate the eligibility conducted by an interview board appointed by the Public Service Commission will be recruited on the basis of the number of vacancies from among the candidates who have fulfilled the qualifications mentioned in the announcement.

Not less than twice the number of officers who submit applications will be called for the interview to evaluate eligibility according to the seniority of those officers. The basic qualification shall also be verified during the interview to evaluate the eligibility.

The interview to evaluate eligibility will be conducted in accordance with the marking scheme approved by the Public Service Commission (mentioned under No. 06).

The number of appointments and the effective date of the appointment will be decided as per the order of the Public Service Commission.
