Or

An equivalent qualifications not below than NVQ Level - 5 which have been approved by the Tertiary and Vocational Education Commission.

Internal Candidates : (1 or 2 below)

01. Having obtained the qualifications required by the external candidate above.

Or

02. Employees of the categories of MA 1 - 2 (Non Tech), having confirmed in the service in RDA.

With

National Certificate in Technology of the Government Technical College or an equivalent qualification not below than NVQ Level 5, approved by the Tertiary and Vocational Education Commission.

02. Age Limit - Below 45 years (Age limit will not apply to those who are presently employed in Govt. department, State Corporations and Statutory Boards)

03. Salary Scale and Grade - (MA 1 - 2) Rs.27,910 - 300 x 18 - 33,310/- plus Government approved allowances.

04. Terms of Employment - The appointment will be on permanent basis.

05. Other Benefits - Employees' Provident Fund contribution by the Authority is 12% against 8% by the Employee plus additional contribution of 3% towards Employees' Trust Fund and other government approved allowance.
