



# Ministry of Highways

Applications are called from the Qualified Sri Lankan citizens for the Internal Auditor Posts in following Foreign Aid Projects which has been established as a Project Management Unit subjected to the Provisions Stipulated in the Management Service Circular No.01/2019 of the General Treasury and implemented coming under the Ministry of Highways.

## Post

**Internal Auditor** - Vacancies for Project Management Units operating under the ministry are recruited on demand.

Qualifications required for the post are given below:

### 1. INTERNAL AUDITOR(PS 4) (Over US \$ 250 million)

#### Minimum Qualifications & Experience (1 or 2 below)

1. A successfully completed Bachelor's Degree in Accounting/Auditing related field which is recognized by the University Grants Commission

Or

A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in Accounting/Auditing related Field.

Or

An Associate membership or similar professional qualification obtained in a relevant field from a recognized professional institution.

With

At least 09 years post qualifying experience in the Auditing related Field.

2. An officer in the Class III/II or above of the Government All Island Services related to the field of Auditing or similar services status.

With

At least 09 years' Experience in a Post of Class III/II in Audit Field

### 2. INTERNAL AUDITOR (PS 4) ( US \$100- 250 million)

#### Minimum Qualifications & Experience (1 or 2 below)

1. A successfully completed Bachelor's Degree in Accounting/Auditing related field which is recognized by the University Grants Commission

Or

A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in Accounting/Auditing related Field.

Or

An Associate membership or similar professional qualification obtained in a relevant field from a recognized professional institution.

With

At least 08 years post qualifying experience in the Auditing related Field.

2. An officer in the Class III/II or above of the Government All Island Services related to the field of Auditing or similar services status.

With

At least 08 years' Experience in a Post of Class III/II in Audit Field

## Conditions :

### 01. Age Limit:

Not more than 64 of age at the closing date.

### 02. Salary:

Salary will be paid based on the Management Service Circular No. 01/2019 of the General Treasury

### 03. Terms of Employment:

The appointment will be on contract basis, initially for a period of one year. Extension could be considered based on the performance.

### 04. Other Benefits:

Employees' Provident Fund contribution by the Project 12% against 08% by the Employee plus an additional contribution of 03% towards Employees Trust Fund from the Basic Salary.
