Applications will be received from qualified Diploma holders for the recruitment to the Grade 1 (c) of Class 3 of the Sri Lanka Teachers Service at Divisional Secretariat Level, in terms of Teachers Service Minute, to fill the teacher vacancies relevant to English subject that exist in Sinhala and Tamil medium schools coming under the Southern Provincial Ministry of Education.

1:1 Basic Qualifications:

- Should be a citizen of Sri Lanka
- Should have obtained a Higher National Diploma in English from the Sri Lanka Institute of Advanced Technological Education (SLIATE)
- Applicants should be residents in the Southern Province continuously for a period of 01 year immediately prior to the application closing date. If an applicant has changed the residence within the Divisional Secretariat Divisions within the Southern Province or has come from some other province to the Southern Province to reside, the permanent residency of the applicant and the residence of the spouse for 01 year should be within the relevant Divisional Secretariat Division for 01 year immediately prior to the closing date of applications.
- Should be physically and mentally fit and possess an excellent moral character
- Age should be not less than 18 years and not more than 40 years as at the closing date of

1:2 Educational Qualifications:

- 1:2:1 Applicants should be diploma holders as stated below as per 13.11 of the Teachers Service Minutes, relevant to recruitment to Grade 1 (c) of Class 3 of the Sri Lanka Teachers Service.
 - "Diploma holder means an individual who has obtained a certificate upon completion of a diploma course after successfully following the course which is not below N.V.Q. Level VI and is of the duration of not less than two years offered by an institution for the relevant purpose which is not a postgraduate diploma as mentioned in 13.11 of the Teachers Service Minutes.
- 1:2:2 Passed G.C.E. (O/Level) Examination in not more than two sittings in 06 subjects with 03 credit passes including mother tongue and Maths.
- 1:2:3 Passed G.C.E. (A/Level) Examination in 3 subjects in one sitting

- As there are not enough qualified graduates of English subject for teaching the English subject in the Southern Province, diploma holders who have fulfilled the specified qualifications may apply.
- 2:2 Recruitments will be done as per the method mentioned below only from applicants who qualify in the written examination conducted by the Southern Provincial Public Service Commission and in the Practical Test conducted by the Southern Provincial Department of Education as per Section 7.2.4 of the new Sri Lanka Teacher Service Minutes, effective as from 01.07.2008
- It is expected to recruit qualified applicants in accordance with the applications received at the Southern Provincial Ministry of Education up to the closing date of applications, who qualify in the written examination and Practical test conducted as mentioned in 2.2 above on the basis of the relevant Divisional Secretariat Divisions of the Southern Province. When filling the Teacher vacancies in schools of the relevant Divisional Secretariat Divisions, applicants residing permanently within the respective Divisional Secretariat Divisions will be recruited first. When qualified applicants are not available within the Divisional Secretariat Division, firstly, applicants from the closest Divisional Secretariat Division or secondly, from the next closest Divisional Secretariat Division to it, based on adjacency, will be selected.

- 3:1 Applications should be self-prepared as per the specimen appearing at the end of this notice using both sides of A4 size paper. It should be prepared containing 1-4 on one side and 5-12 on the other side
- 3:2 Applications that do not conform to the specimen application and incomplete applications will be rejected. Further, Divisional Secretariat Divisions and the relevant number of the permanent residency should be correctly stated. Applicants who do provide incorrect information are subject to cancellation of appointment after selection if found that false information has been submitted.
- Duly completed applications should be sent by registered post addressed to "Secretary, Southern Provincial Ministry of Education, "Dakshinapaya", Labuduwa, Galle", to be received on or before 31.03.2021. The cover containing the application should be marked "Recruitment of Diploma Holders for English Teacher Vacancies existing in the Schools of Southern Provincial Council - 2021".
- The Receipt received for the payment of the Examination Fee of Rs. 1000/- made to any Divisional Secretariat Office in the Southern Province, credited to the Revenue Title No. 2003.02.13 of the Chief Secretary of the Southern Province, should be affixed firmly to the back of the application.
- Complaints with regard to applications lost or delayed in the post will not be entertained and late applications shall not be considered under any circumstances
- Note: A photocopy of the Diploma Certificate with details should be compulsorily attached to the application. Applications without them may be rejected.
