

Post: ASSISTANT MANAGER (Civil) - Estates Grade II

Qualifications and Experience

I. Should have obtained a B.Sc. Engineering (Civil) degree recognized by the **University Grants Commission**

II. Should have obtained a Competency Certificate of not less than N.V.Q Level Seven (07) issued by a Technical/Vocational Training Institute recognized by the Tertiary and Vocational Education Commission

III. Should have obtained a Competency Certificate of not less than N.V.Q Level Six (06) issued by a Technical/Vocational Training Institute recognized by the Tertiary and Vocational Education Commission

With

At least four (04) years experience in the relevant field in a Government Department / Corporation / Board / statutory institution

Or

IV. Should have obtained a Competency Certificate of not less than N.V.Q Level five (05) issued by a Technical/Vocational Training Institute recognized by the Tertiary and Vocational Education Commission

With

At least ten (10) years experience in the relevant field in a Government Department / Corporation / Board / statutory institution

Salary Category : JM 1-2

Salary Scale : Rs. 43,355/- 775x10 - 1135x18 - 71,335/-

: Should be not less than 22 years and not more than 45 years. Age

Maximum age limit is not applicable to applicants already in Government / Corporation / Boards and to internal applicants.

Other Conditions

Every applicant;

- Should be a citizen of Sri Lanka
- II. Should be physically and mentally fit to discharge the duties entrusted to the post and to serve in any part of the island.
- Should have an excellent moral character.
