- Should pass minimum of 06 subjects at G.C.E. (Ordinary Level) Examination with at least 05 credit passes in one and the same sitting. It is compulsory to possess credit passes for Sinhala/Tamil Language, Mathematics and English Language.

Should possess minimum of 03 Simple passes at G.C.E. (Advanced Level) Examination (Excluding General English) in one and the same sitting.

AGE

Age should be not less than 18 years and should not be more than 23 years as at closing date of applications. (Candidates shall be treated as having satisfied the qualifications relating to the age if his/ her date of birth falls on or before 02.06.2003 or on or after 02.06.1998)

- While the selected candidates should consent to serve in any part of the Island, it is compulsory for them to serve for a minimum period of five years continuously in the Work Station/Region where they will be initially attached to
- Candidates who are recruited under this scheme will be referred to a formal and, comprehensive training covering all the aspects of banking on a four year contract basis.
