**01) Director (Enforcement and Implementation) (01 Post)**

**i) Job Description**

Interpretation and implementation of all other laws and regulations including the Act relevant to the establishment of the Authority liaise with international institutions engaged in banned steroids timely updating of laws and regulations and information and follow them in Sri Lanka, work in coordination with state institutions and private sector institutions in our country relevant to the banned steroids implementing of Senior Management duties entrusted by the Director General and duties entrusted by the Act relevant to the establishment of the Authority.

Obtained a Master's Degree in the relevant field and minimum of fifteen (15) years experience in a "Management Level" post in a Government, State Corporation, Board, Statutory Institution or a reputed Private Sector Institution.

- 2) Completed a satisfactory service period of at least five (05) years in the relevant subject field, in a Grade 1 post in Management Services (MM) Service Category.
