Applications are hereby invited from citizens of Sri Lanka, who are eligible and having qualifications for the posts described below of the Tower Hall Theatre Foundation to nurture and enrich the Drama and Performing Arts field of Sri Lanka. These posts are permanent, entitled to Employees Provident Fund (EPF) and Employees Trust Fund (ETF).

**Senior Management Service Category -
(HM 1-1)**

**01. Director (Drama Promotion, Education
and Programmes) - No of Posts - 01**

Description of Employment :

The main responsibility of the post is to promote the Drama and Theatre Art Schools qualitatively and quantitatively and monitor and supervise them, which are affiliated to the Town Hall Theatre Foundation and in the Three Divisions of the Drama Promotion, Programmes and Education Sections of the Institution and work for the promotion and uplift of the Drama and Theatre Arts, aiming towards the fulfilling of objectives of the foundation under the instructions / advice and guidance of the Director General of the Foundation, who is the Chief Executive Officer of the Institution and of the decrees and decisions of the Board of Trustees of the Tower Hall Theatre Foundation.

Basic qualifications and experience needed for external applicants :

- (a) Degree in the field of Drama and Theatre Arts, Education, Aesthetics, Arts, Mass Communication subject field obtained from a University, recognized by the University Grants Commission (UGC) with Postgraduate Degree (Masters) in the relevant field and

Having gained minimum fifteen (15) years of experience in relevant field in a post of Management Level in the Public Sector, State Corporation, Board, Statutory Institution or in a recognized Private Sector Institution.

Policies issued from time to time, utilizing the Code of Establishment, Financial Regulations for the achievement of the objectives of the Tower Hall Theatre Foundation Act.

Basic qualifications and experience required for the External Applicants

Responsibilities entitled to this post are constructions at Theatre Halls and of all the premises, belonging to the Tower Hall Theatre Foundation, all electricity, air-conditioning, water supply and drainage works and other technical related works and daily maintenance work. Submission of recommendations regarding them and

if maintenance and repair works are done by external parties, monitoring and supervision on them and provision of recommendation that those works were successfully carried out, etc.
