Context:

Under the Direct Supervision of the Senior Nurse (MH), and the overall supervision of the Chief Migration Health Officer (MH), the candidate will be responsible for the following duties and responsibilities;

Core Functions / Responsibilities:

- 1. Briefing and counselling medical procedures to the clients, paying special attention to radiology and laboratory testing;
- 2. Interview applicants for identification of risk factors and perform necessary investigations in coordination with the laboratory technician:
- 3. Assist in specimen collection, paying special attention at correct identification of clients labelling of samples and reporting;
- Assist the Senior Nurse in conducting initial screening for health assessment including history taking, clinical assessment, treatment, immunization and collating medical reports;
- 5. Assist the Senior Nurse in sample collection as required. Ensure safety and confidentiality of all procedures in coordination with the laboratory technician;
- 6. Ensure all the samples are transported to the relevant laboratories according to the international and IOM standards in the absence of laboratory technician.
- 7. Coordination with the relevant laboratories and timely collection of laboratory results and reports, in the absence of Laboratory Technician.
- 8. Maintain records and registers of applicants who undergo medical investigations.
- 9. Cover up the specified duties of the medical laboratory technician and the radiographer, as and when required.
- 10. Assist the Senior Nurse and the physicians to ensure adequate treatment and follow up of the clients who undergo specific treatment schedules;
- 11. Assist with registration, data entry and other medical administrative functions; Maintain daily, monthly and annual statistics and perform data analysis;
- 12. Participate in field follow up as and when required.

Required Qualifications and Experience

Education

- University Degree in Nursing from an accredited academic institution with Two (2) Years of Professional Experience in the related field: or
- Four (4) years related work experience in the field of nursing with a Diploma in Nursing will be advantageous.
- A valid licence (SLMC Reg.) to practice as a nurse in Sri Lanka.

Experience

- Experience in briefing and counselling the clients is a strong requirement;
- Administrative & Clerical work experience, preferably within the International Humanitarian Field will be advantageous;

- Effectively applies knowledge on health issues;
- Effectively coordinates actions with other implementing partners;
- Works effectively with local authorities, stakeholders, and beneficiaries.

Fluency in English and Sinhalese / Tamil is required; Fluency in multiple languages is advantageous;
