## **POST OF ASSISTANT INTERNAL AUDITOR (ON CONTRACT - SECONDMENT BASIS)**

### **Qualifications:**

1. Pass in the final II examination of the Institute of Chartered Accountants of Sri Lanka or its equivalent **OR**
2. (a) (i) Should possess a Bachelor's Degree specialized in Accounting from a recognized University/HEI **OR**  
(ii) Should possess a Bachelor's Degree from a recognized University/HEI with pass in the Intermediate Level Examination of the Institute of Chartered Accountants of Sri Lanka or its equivalent **OR**  
(iii) Should possess a Higher National Diploma in Accountancy (HNDA) of Sri Lanka Institute of Advanced Technological Education (SLIATE) or its predecessor **AND**
- (b) Two (02) years of experience in Accounting / Auditing in a Government/State corporation or Reputed private sector organization.

**Note:-** Preference will be given to those who have experience in Accounting and Auditing in a state organization

**Duration:** One year (extendable)
