





# CLIMATE SMART IRRIGATED AGRICULTURE PROJECT (CSIAP)

## **Recruitment of Project Staff**

The Climate Smart Irrigated Agriculture Project (CSIAP) implemented by the Ministry of Agriculture and funded by the World Bank is for a period of 5 years (2019 to 2024). The objective of the Project is to improve the agriculture productivity via improving climate resilience agriculture in climatically vulnerable hotspot areas identified in six provinces namely North Western, North Central, Eastern, Northern, Southern and Uva. The estimated cost of the project is USD 125 Mn.

Applications are invited from citizens of Sri Lanka for the following posts in the project on contract basis. The applicants should possess the following qualification and experience given under each category.

## 01. <u>Climate Smart Agriculture Specialist (PS 3) – 01 Position at Eastern Province</u>

### Qualification (a) or (b) or (c) below.

- a) A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an Associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field **with** at least 12 years of post-qualifying experience in the Managerial Level.
- b) A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an Associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field **and** a Post Graduate Degree in the relevant field or Corporate/ Charted membership or a similar professional qualification obtained from recognized professional from recognized professional institution in the relevant field **with** 09 years of post-qualifying experience in the Managerial Level
- c) A Class I officer of the Government All Island Services or a similar status in the relevant field **with** at least 4 years of experience in a Class I post.

## A brief job description for Climate Smart Agriculture Specialist -

Develop and overall agriculture development framework & strategies for the hot spot area and to promote climate smart agriculture (CSA) technologies & practices and related activities in hot spot area.

#### 02. Project Accountant (PS 4 - Category A) 01 position at Eastern Province

#### Qualification (a) or (b) below.

- (a) A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an Associated membership/ a similar professional qualification obtained from the recognized professional institution in Accounting or Finance **with** at least 08 years post-qualifying experience in the relevant field.
- (b) An officer of the Government All Island Services Class III/II or above or similar status in the relevant field **with** at least 08 years of experience in Class III/II post

**A brief job description for Project Accountant:** The concern candidate should familiar with Government accounting system, assets management and stores management, The candidate with experience in World Bank and/ or foreign funded projects will be given preference.

#### 03. Senior Technical Officer (PS 5) - 01 position at North Western Province.

#### Qualification (a) or (b) or (c) below.

- a) A Bachelor's Degree in Civil Engineering, which is recognized by the University Grants Commission **or** a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field **or** an Associate membership/ a similar professional qualification obtained from a recognized professional institution in the relevant field **or** having obtained a certificate of proficiency not below than the National Vocational Qualification Level-7 issued by a Technical/ Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to relevant field **and** at least 5 years of experience in the relevant field.
- b) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level- 6 issued by a Technical/ Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to relevant field and at least 10 years of experience in the relevant field.
- c) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level- 5 issued by a Technical/ Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to relevant field and at least 15 years of experience in the relevant field

**A brief job description:** To assist the Provincial Deputy Project Director and Project Engineers in Project Management Unit for Surveying and Leveling, Drawing, Designing, Taking-off quantities, Estimating, setting out, supervision and quality control, checking measurements for payments, etc. of all Civil Engineering constructions carried out under the CSIAP including Supervision of Technical officers and Draftspersons.

# 04. <u>Environmental Safeguard Officer (PS 6 - Category A) 01 position at North Western</u> <u>Province</u>

## Qualification (a) or (b) or (c) below.

- a) A bachelor's degree in the relevant field which is recognized by the University of Grants Commission or a qualification recognized by the University Grants Commission as an equivalent qualification to the degree in the relevant field or an associate membership/a similar professional qualification obtained from a recognized professional institution in the relevant field or having obtained a certificate of proficiency not below than the National Vocational Qualification Level-7 issued by a Technical/ Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to relevant field with at least 3 years post qualification experience in the relevant field.
- b) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 6 issued by a Technical/ Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to relevant field with at least 8 years of post-qualification experience in the relevant field.
- c) Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 5 issued by a Technical/ Vocational Training Institute accepted by Tertiary and Vocational Education Commission for a post related to relevant field **with** at least 13 years of post-qualification experience in the relevant field.

A brief job description for Environmental Safeguard Officer: To assist the Provincial Deputy Project Director and Environmental Social Safeguard Specialist for implementation of Environmental and Social Management Framework (ESMF), implementation of site specific Environmental & Social Management Plans (ESMPs) and monitoring of site-specific ESMPs to ensure that all legal amendments, regulations and procedures to be developed under the project, to ensure that all required environmental mitigation measures set out in plans.

- 1. Age Limit Below Sixty-four (64) years on the closing date of application
- **2.** All appointments will be initially for a period of one year and extension of services will be based on successful performance.
- **3.** Employees are required to travel to project sites depending on the need.
- **4.** Working experience in the foreign funded projects in Sri Lanka is preferable
