POST OF WORKS ENGINEER (CIVIL) GRADE III

The University of Colombo will entertain applications from suitably qualified persons for the above post up to 06th February 2023.

01. QUALIFICATIONS:

(a) Should have a B.Sc. Engineering Degree specializing in Civil Engineering from a University/Higher Educational Institution recognized by the UGC and the Institution of Engineers Sri Lanka (IESL) and registered as an Associate Engineer or above at the Engineering Council of Sri Lanka (ECSL).

<u>OR</u>

(b) Should have a Bachelor of Engineering Technology (BET) degree specializing in Civil Engineering Technology or Construction Technology from a University/ Higher Educational Institution recognized by the UGC with at least two (02) years of experience in Civil Engineering works in a recognized establishment, and registered as an Affiliate Engineer or above at the Engineering Council of Sri Lanka (ECSL).

<u>OR</u>

(c) Should have a National Diploma in Technology specializing in Civil Engineering or equivalent with at least seven (07) years of experience in Civil Engineering works in a recognized establishment and registered as an Incorporated Engineer or above at the Engineering Council of Sri Lanka (ECSL).

Note: The in-plant training period shall not be counted for the period of experience.

02. SALARY AND OTHER CONDITIONS OF APPOINTMENT:

Salary Code: U-EX 1 (II):

Rs. 50,625 – 3 x 1,125 – 54,000 (EB) 55,335; 12 x 1,335 – 71,355 p.m. (as at 01.01.2020)

The selected candidate will be a member of the Universities Provident Fund as well as of the University Pension Scheme. He/ She will contribute 10% of his/her monthly salary to the Universities Provident Fund and at the same time the employer will make a total contribution of 15% of his/her salary of which 8% will be credited to the Universities Pension Fund and 7% to the Universities Provident Fund. Three percent (3%) of the salary will be contributed by the University to the Employees' Trust Fund in terms of the provisions of the Employees' Trust Fund Act, No. 46 of 1980.

The other conditions of appointment will be in accordance with provisions of the Universities Act No. 16 of 1978, Universities (Amendment) Act No. 7 of 1985 and Universities (Amendment) Act No. 1 of 1995 and Ordinances, By-laws, Regulations and Rules, etc. made thereunder.

03. Applicants will be shortlisted according to their qualifications & experience and the shortlisted applicants will be summoned for a structured interview.
