# **JOB ANNOUNCEMENT**

State Owned Enterprise (SOE) reforms are a pivotal part of the Government's (GoSL) reform program. As part of this process, an SOE Reform policy has been approved by the Cabinet of Ministers and SOE legislation is being drafted to give effect to this policy. Further, the Cabinet of Ministers has given approval in principle for the divestiture of identified state entities. For four of these entities, GoSL has,via both the local and international press, called for expressions of interest whilst for the others, this will be done shortly. Other divestitures will be scheduled as and when approval is received from the Cabinet of Ministers.

The SOE reforms are being carried out by the SOEs Restructuring Unit (SRU), formed under the Ministry of Finance, Economic Stabilization and National Policies. Given the importance of SOE restructuring, several Multilateral Agencies are providing assistance to the SRU.

The Ministry of Finance, Economic Stabilization and National Policies is now seeking to engage Sri Lankan professionals on contractual basis who are suitably qualified and experienced to join the SRU.

## Job Title: Deputy Director General (Transactions)

### **Responsibilities :**

The Deputy Director General(Transactions) will oversee all transactions relating to SOEs and will lead and manage individual transaction teams. The role will also involve liaising with line Ministries and local and international technical advisors and consultants.

### **Qualifications :**

The ideal candidate will have a minimum of a Master Degree or equivalent qualifications such as Chartered Financial Analyst (CFA). A degree in Finance, Mathematics, Statistics, Economics or Engineering would be an advantage.

### Experience :

Ideal candidate with minimum of 15 years' experience with at least 10 years of which in investment banking or management consulting at a senior level. The candidates should have experience in mergers and acquisitions, corporate valuations, financial structuring, transaction structuring. The candidates with a strong understanding of capital markets and experience in dealing with the Securities and Exchange Commission and the Colombo Stock Exchange (CSE)would be a distinct advantage.

Candidates must have strong leadership, strategic thinking and negotiating skills and a high level of integrity and professionalism together with the ability to work towards tight deadlines.

#### **Responsibilities :**

The Head of Legal will be responsible for the overall legal strategy with respect to the activities of the SRU and will advice and guide the reforms team and the transactions teams in the discharge of their responsibilities. #### Qualifications : LLB with Attorney-at-law

#### **Experience** :

The ideal candidate will have at least 10 years' experience in corporate and commercial law at a senior level at the Attorney General's Department, in a recognized firm of lawyers and / or in a reputed corporate. Experience in investment related due diligence, mergers & acquisitions, IPOs and transaction structuring will be an advantage.

# Job Title : Senior Project Officer (Financial Analyst) - Two Posts

### **Qualifications :**
