### Post of Director - Finance

The Ocean University of Sri Lanka was established for the purpose of enhancing the scientific, technical, and managerial skills of persons engaged in the fields of fisheries, ocean sciences, maritime technologies, and allied fields.

The Ocean University of Sri Lanka invites applications from prospective candidates for the post of Director- Finance, a permanent appointment equal to the Post of Bursa of the National University system.

#### 1. QUALIFICATIONS:

a. Should possess a Bachelor's Degree (Accounting/ Business Management/Commerce) specialized in accounting which is recognized by the University Grants Commission

with

A Masters' Degree in Accounting/ Finance Management field

or

Associate Membership of a recognized Professional Association including the Institute of Chartered Accountants of Sri Lanka (ICASL)/Chartered Institute of Management Accountants (CIMA)/ Association of Chartered Certified Accountants (ACCA)

And

Minimum of 15 years' experience at a Managerial Level in a University/Corporation/ Statutory Board/Reputed Private Institute.

b. Full membership of a recognized Professional Association including the Institute of Chartered Accountants of Sri Lanka (ICASL)/Chartered Institute of

Management Accountants (CIMA)/ Association of Chartered Certified Accountants (ACCA)

and

Minimum of 15 years' experience at a Managerial Level in a University/Corporation/ Statutory Board/Reputed Private Institute.

**2. AGE :**

Age should be not less than 35 years and not more than 55 years. The upper age limit will not apply to the internal candidates.

**3. SALARY - UEX3 (II) :**

Rs. 95,320-7 x 2170:11 x 2700-140,210 p.m. as of 01.01.2020. In addition to the above salary, cost of living allowance, and other government-approved allowances will be paid to the selected candidate.

**4. OTHER BENEFITS :**

The appointee is required to contribute 8% of the monthly salary to the EPF while the employer will contribute a sum of 12% of that salary and 3% to ETF.

**5. METHOD OF RECRUITMENT :**

Selection by interview.

**6. GENERAL CONDITIONS :**

- iii. Applications received after the closing date /not in conformity with the above requirements/ incomplete applications will be rejected without intimation.
