(i) A First or Second Class in the B.Sc. Special Degree in Computer Science/ Computer Engineering from a recognised University;

(ii) (a) A Pass in the B.Sc. Special Degree in Computer Science/ Computer Engineering from a recognised University;

**or**

A First or Second Class in the B.Sc. General Degree with computing as a subject component from a recognised University;

**and**

(b) One year experience in the field of computing;

**OR**

(iii) (a) A Pass in the B.Sc. General Degree with computing as a subject component from a recognised University;

**or**

A First or Second Class in the B.Sc. General Degree (where computing is not a subject component) from a recognised University;

**and**

(b) Two years experience in the field of computing;

**OR**

(iv) (a) A Pass in the B.Sc. General Degree (where computing is not a subject component) from a recognised University;

**and**

(b) Three years experience in the field of computing;

**OR**

(v) (a) Any other degree

**and**

- (b) A Postgraduate Diploma in Computer Science/ Computer Technology from a recognised University.

**and**

- (c) One year experience in the field of computing

**OR**

- (vi) 15 years experience as a Computer Programmer in the University Service.

*(Preference will be given to those who have mathematical-based software and programming.)*

**Note:**

Selection will be made by a **structured interview** formulated by the University.

**02. SALARY AND OTHER CONDITIONS OF APPOINTMENT :**

Rs. 80,000/- (Basic) + Cost of Living (Rs. 7,800/-) + Monthly Allowance (Rs. 5,000/-) + EPF + ETF

- The appointment will be on a contract basis initially for a period of one year and the period of contract will be renewable subject to the performance of the selected person and the requirement of the university.
