A Minimum of two (02) years satisfactory service in a post in the Senior Manager Category (HM 2-1) in the Board.

A proven ability to lead and direct multi-disciplinary teams. Experience in proper deployment and efficient management of human and other resources.

# (c) For Officers of Public Service :

Since officers in Class One or above in Sri Lanka Administrative Service could be appointed on secondary basis to perform the powers, duties and work of Sri Lanka Export Development Board they could apply

# **Job Description :**

Minimum of 15 years experience at a "Managerial Level" in a Corporation / Statutory Board / Institution or a reputed private institution.
