02. Date of Qualification:

Applicant is accepted as qualified to apply for the above service / post only if had fulfilled the required qualifications in every aspect as at the closing date of applications.

03. Nature of the Appointment:

This post is permanent. Employee should contribute 10% of the salary to the Employees Provident Fund (EPF) while the Authority will contribute 15% to the Employees Provident Fund and 3% to the Employees Trust Fund (ETF).

04. Examination Fees:

05. Method of Applying:

- Applicant should self prepare the application in A4 size paper on single side to consist personal details in page 1, Educational Qualifications in page 2, Professional Qualifications and job experience in page 3, extracurricular activities in page 4, and should include names and contact details of two (02) non-related referees in the application.
- 2) It is mandatory that the applicants for the post of Management Assistant (Non Technical) mention the medium (Sinhala / Tamil) of sitting the examination.
- Duly completed applications along with certified photocopies of 2 recently obtained character certificates, Grama Nildhari's certificate, police report, national identity card, all educational certificates and certificates of other qualifications should be sent by registered post addressed to "Chairman, Marine Environment Protection Authority, No. 177, Nawala Road, Narahenpita, Colombo 05" to receive before 04.04.2024. Post applying for should be clearly mentioned on the left hand top corner of the envelope containing the application.
