

<u>University of Kelaniya - Sri Lanka.</u> <u>Vacancies</u>

Applications are invited from qualified persons to fill the vacancies at the Faculty of Computing and Technology of the University of Kelaniya.

01. Post : Technical Officer (ICT) Grade III

Qualifications :

(i) Should have passed in three (03) subjects at the G.C.E. (A/L) examination in one sitting in any Stream.

AND

- (ii) Having obtained a certificate of proficiency not below than the N.V.Q. Level 5 issued by a Technical / Vocational Training Institute accepted by the Tertiary and Vocational Education Commission or recognized Institution in the field of Information Communication and Multimedia Technology / Information and Communication Technology / Information Technology or Equivalent.
- Preference will be given for those who have work experience in ICT.
- Age should be not less than 18 years and not more than 45 years.

Salary Method : U-MT 1 (III A) Rs. 31,625 - 7 x 300; 10 x 355 - 37,275 (Monthly) (According to the UGC Circular 17/2016(v))

Method of Selection : By Written and/or Practical test and an interview.

02. Post : Technical Officer Grade II Segment "B"

Qualifications:

- i. Three (03) G.C.E. A/L(Advanced Level) passes in Science subjects in one sitting; required subject combinations as follows,
 - 01 Chemistry, Physics, Combined Mathematics
 - 02 Chemistry, Physics, Biology

AND

ii. Passed a skill-oriented formal programme of training relevant to the post of at least one year (full-time) duration or equivalent. The acceptability of the training programme for this purpose shall be judged by the faculty concerned.

Age Limit - Not more than 35 years.

Note:- Appointment under "Segment B" of the technical Officer's service will be made as "**Trainee Technical Officer**" for a period of 03 years on a fixed salary of Rs. 31,625 + (other allowances). At the conclusion of training those who have gained competence in Laboratory techniques, including maintenance of inventories and ability to type in English will be confirmed and appointment made to permanent post of Technical Officer Grade II – Segment "B"

Method of Selection : By Practical test and interview.

03. Post : Management Assistant (Grade III)

Qualifications :

- I. Should have passed the G.C.E (O/L) Examination in six (06) subjects at one sitting with credit passes in :
 - i. Sinhala Language / Tamil Language
 - ii. English Language / English Literature
 - iii. Mathermatics

&

- II. Should have passed in all subjects at G.C.E (A/L) Examination (except the common General Paper) at one sitting.(Passing in 3 subjects under the old syllabus at one sitting would be sufficient for this purpose.)
- III. Preference will be given to those who possess the following;
 - i. An acceptable qualification in computer applications of not less than six (06) months duration obtained from a recognized institute.

AND

ii. Two years of experience in the use of computer application packages.

NOTE :- Eligibility

- a) Should be a citizen of Sri Lanka.
- b) Should be not less than 18 years and not more than 30 years of age on the closing date of applications.
- c) Should be of good character.

Method of Selection : By Written Examination (75% marks) of following Subjects and interview (25% marks).

- Knowledge in Sinhala / Tamil & English Language
- Intelligent quotient and General Knowledge
- Computer Literacy

04. Post : Machinist (Grade II)

Qualifications :

- i. Should have passed at least 7th standard.
- ii. Should be conversant with
 - a) Reading scales to 1/64" and setting micrometers
 - b) The name, uses and the maintenance of all tools and attachments pertaining to the trade
 - c) Reading and understanding all drawings pertaining to the work
 - d) Operating proficiently the machines (viz: drilling, shaping, grinding or lathes).
- iii. Not less than 2 years' experience in a recognized workshop.
- iv. Age not more than 40 years.

Salary Method : U-PL 3 (III) Rs. 29,915 - 16 x 270 - 34,235 (Monthly)

(According to the UGC Circular 17/2016(v))

Method of Selection : By trade test and interview.

05. Post : Fitter (Grade II)

Qualifications :

- i. Ability to read and write
- ii. Should be conversant in reading scales up to 1/64" and recording fractional dimensions. Reading and understanding drawing, setting of various types of fitting in steam, motor and diesel driven engines and governors etc., knowledge in reading micrometer.
- iii. Not less than 2 years' experience as a fitter in a Government Department, State Corporation or in Engineering establishment.
- iv. Age Not more than 40 years.

Salary Method : U-PL 3 (III) Rs. 29,915 - 16 x 270 - 34,235 (Monthly) (According to the UGC Circular 17/2016(v))

Method of Selection : By trade test and interview.

06. Post : Welder (Grade II)

Qualifications :

- i. Ability to read and write.
- ii. Should be conversant with
 - a) Reading scales up to 1/32" Reading and understanding simple drawings, methods of preparation of various works for weiling, Preparation and performing butt, ilap, fillet, corners, and other types of welding.
 - b) Electrodes and various sizes used for different sections and materials current control. Horizontal and vertical and overhead welding.
 - c) Clip, and filling to fine finish. Detecting and rectifying minor faults in acetylene generating plants, correct method or gas cylinders.
- iii. Not less than 2 years' experience as a welder in a Government Department, State Corporation or in a recognized engineering establishment.
- iv. Age Not more than 40 years.

Salary Method : U-PL 3 (III) Rs. 29,915 - 16 x 270 - 34,235 (Monthly) (According to the UGC Circular 17/2016(v))

Method of Selection : By trade test and interview.

07. Post : Laboratory Attendant (Grade III)

Qualifications :

i. Should have passed the G.C.E O/L Examination in six subjects (06) with at least two credits passes in not more than two sittings.

AND

ii. Having obtained a certificate of proficiency of the N.V.Q. Level 2 or 3 in a field which has knowledge of standard laboratory equipment and laboratory techniques issued by a Technical / Vocational Training Institute accepted by the Tertiary and Vocational Education Commission or a statutory institution which has been established by an Act passed by the Parliament.

Note : Minimum 6 months working experience in a similar capacity with knowledge and use of standard laboratory equipment, supplies and ability to learn new laboratory techniques as needed may consider equal to NVQ Level 2 or 3 until such programs are designed as appropriate for the post of Laboratory Attendant.

iii. Age should be not less than 18 years and not more than 45 years.

Method of Selection : By aptitude test and interview.

08. Post : Works Aide (Grade III)

Qualifications :

i. Should have passed the G.C.E O/L Examination in six subjects (06) with at least two credits passes in not more than two sittings.

NOTE :-

a) Should be a citizen of Sri Lanka.

- b) Should be not less than 18 years and not more than 45 years of age on the closing date of applications.
- c) Should be of good character sound physical health.

Salary Method : U-PL 1 (III) Rs. 27,025 - 16 x 250 - 30,775 (Monthly) (According to the UGC Circular 17/2016(v))

Method of Selection : By competitive examination and / or structured interview.

Method of Application :

Duly completed Applications on prescribed forms should be sent with copies of relevant certificates, indicating the post applied for on the top left hand corner of the envelope to reach the Assistant Registrar/ Non-Academic Establishment Division, University of Kelaniya, Dalugama, Kelaniya, to be received on or before 17th May 2024.

Applicants from higher Education Institutes, Government Departments, Corporations and Statutory Boards and they should channel their applications through the respective Head of Institutions.

The University reserves the right to shortlist the candidates and/ or not to recruit all the above positions or any of them due to a reason satisfied by Council. The decision of the Council would be the final in this regard.
