# 01. EDUCATIONAL QUALIFICATIONS

## (A) <u>Temporary Lecturer</u>:

(1) A Degree in BBA/BBM/B. Com/B.Sc. with specialisation in **Finance** with First or Second Class (Upper Division) Honours;

<u>OR</u>

(2) A Degree in BBA/BBM/B. Com/B.Sc. with specialisation in **Finance** with Second Class (Lower Division) Honours;

OR

(3) (a) A Degree in BBA/BBM/B. Com/B.Sc. with specialisation in **Finance** without honours or any other Degree with at least Second Class Honours;

<u>and</u>

(b) (i) A Doctoral Degree in **Finance** or in the relevant field

or

(ii) A Masters Degree in **Finance** or in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/dissertation

or

(iii) A full time Masters Degree in **Finance** or in the relevant field of a minimum of 18 months duration with at least 60 credits\* of which not less than 15 credits\* of research by way of thesis/dissertation

{\*One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)}

# **NOTES:**

- (i) Candidates who are eligible under category (A)(1) above will be interviewed and evaluated first.
- (ii) Candidates who are eligible under category (A)(2) and (A)(3) above could be invited for an interview only if applicants qualified under category (A)(1) above are either not available or found to be unsuitable by the Selection Committee after interview and evaluation.
