Applications submitted without Form A will not be entertained.**

Applications and all the relevant documents received after the closing date and incomplete applications and applications not submitted in prescribed format of the University of Moratuwa will be rejected without intimation.

(1) (i) A degree with specialization in the relevant subject with First or Second Class (Upper Division) Honours;

OR

(ii) A Degree with specialization in the relevant subject with Second Class (Lower Division) Honours;

OR

(iii) (a) A Degree with specialization in the relevant subject without Honours or any other degree with at least Second Class Honours,

AND

(b) A Postgraduate Degree of at least two academic years duration in the relevant subject with a research component by way of thesis/dissertation;

OR

- (iv) Such Academic or Professional Qualifications or Professional experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned.

AND

- (2) (i) (a) A Doctoral Degree in the relevant field

OR

- (b) A Masters Degree in the relevant field with full time research of at least 24 months duration.

OR

- (ii) Such professional qualifications and experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned.

AND

- (3) At least twelve (12) years experience [of which not less than six (06) years should have been after obtaining qualifications stipulated in 02 above] in one or more of the following:

- (i) Teaching at University Level
- (ii) Professional Experience
- (iii) Research in a recognized Institution
- (iv) Postgraduate Studies

Notes:

- (a) A Senior Lecturer Grade I may be confirmed in the post on completion of three years satisfactory service in the permanent cadre and completion of an induction training course which includes (Teaching/Learning Methodologies) within a period of one year from the date of first appointment. The University Grants Commission will organize this course of training.
- (b). A Senior Lecturers Grade I is entitled for Sabbatical leave of one year duration with pay or two years sabbatical leave with no-pay after seven years of service and are also eligible to receive passage for the staff member and the spouse

(B) Senior Lecturer Grade II

- (1) (i) A degree with specialization in the relevant subject with First or Second Class (Upper Division) Honours;

OR

- (ii) A Degree with specialization in the relevant subject with Second Class (Lower Division) Honours;

OR

- (iii) (a) A Degree with specialization in the relevant subject without Honours or any other degree with at least Second Class Honours,

AND

- (b) A Postgraduate Degree of at least two academic years duration in the relevant subject with a research component by way of thesis/dissertation;

OR

- (iv) Such Academic or Professional Qualifications or Professional experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned.

AND

- (2) (i) (a) A Doctoral Degree in the relevant field

OR

(b) A Masters Degree in the relevant field with full time research of at least 24 months duration.

OR

(ii) Such professional qualifications and experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned

AND

(3) At least six (06) years experience in one or more of the following:

- (i) Teaching at University Level
- (ii) Professional Experience
- (iii) Research in a recognized Institution
- (iv) Postgraduate Studies to acquire the qualifications stipulated at (2) above.

Notes:

- (b) A Senior Lecturer Grade II may be confirmed in the post on completion of three years satisfactory service in the permanent cadre and completion of an induction training course which includes (Teaching/Learning Methodologies) within a period of one year from the date of first appointment. The University Grants Commission will organize this course of training.
- (c) A Senior Lecturers Grade II is entitled for Sabbatical leave of one year duration with pay or two years sabbatical leave with no-pay after seven years of service and are also eligible to receive passage for the staff member and the spouse.

(C) Lecturer (Un-Confirmed)

(1) (i) Candidates shall possess the Academic Qualifications required for Lecturer (Probationary) [Non-(Medical/Dental)] as per category (1) or (2) of post No. 02 of commission Circular No. 721 as amended.

AND

(ii) A Master's Degree (as specified in para. 3 of Commission Circular No. 08/2016) or doctoral Degree, in the relevant field (but, less than 06 years of experience as specified in the Scheme of Recruitment for Senior Lecturer Grade II, by open advertisement, given in Post No. 6 of Commission Circular No. 721 as amended).

Notes:

- a) An applicant who qualifies for Lecturer (Probationary) [Non-(Medical/Dental)] as per category (3) of post No. 02 of Commission Circular No.721 as amended, but less than 06 years of experience as specified in the Scheme of Recruitment for Senior Lecturer Grade II, by Open advertisement, given in Post No. 06 of Commission Circular No.721, may be exempted from (ii) above if he/she has a Doctoral Degree in the relevant field.
- b) An applicant who qualifies for Lecturer (Probationary) [Non-[Medical/Dental)] as per Category (3) of Post No. 02 of Commission Circular No. 721 as amended, and he has a Master's Degree (as specified in para. 3 of Commission Circular No.08/2016) but less than 06 years of experiences as specified in the Scheme of Recruitment for Senior Lecturer Grade II, by open advertisement, given in Post No. 6 of Commission Circular No 721 as amended, may be exempted from above (ii) if he/she has evaluated research and dissemination of knowledge for a minimum total of 15 marks. The Section 2 and sub-section 3.1 of the Marking Scheme for the posts of Associate Professor/Professor should be used for this purpose.

Special Notes:

- 1. A Lecturer (Unconfirmed) [Non-(Medical/Dental)], who has completed the three years period of satisfactory service and the induction training course within a period of one year from the date of appointment, may be confirmed in the post of Lecturer [Non- [Medical/Dental)], provided such lecturer has fulfilled all other requirements specified in the letter of appointment.

2. The Confirmed Lecturer [Non-(Medical/Dental)] may be considered for promotion to Senior Lecturer Grade II [Non-(Medical/Dental)] upon fulfilling 5 years of experience (along with the experience as defined under Post No. 06) and satisfying the other requirements as specified in the Specified in the Scheme of Recruitment under Post No. 07 of Commission Circular No.721.
3. The effective date of the promotion to the post of Senior Lecturer Grade II of only those appointed as Lecturer (Unconfirmed) [Non-(Medical/Dental)] based on a Doctoral degree, may be backdated to the date on which they have completed 6 years of experience as per Post No 06, by placing them on the relevant salary step, with no back wages being paid.

(D) Lecturer (Probationary)

- (1) (i) A degree with specialization in the relevant subject with First or Second Class (Upper Division) Honours;
- OR**
- (ii) A Degree with specialization in the relevant subject with Second Class (Lower Division) Honours;
- OR**
- (iii) (a) A Degree with specialization in the relevant subject without Honours or any other degree with at least Second Class Honours,
- AND**
- (b) A Postgraduate Degree of at least 02 academic years duration in the relevant subject with a research component by way of thesis/ dissertation.
- OR**
- (iv) Such Academic or Professional Qualifications or Professional experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned.

Notes:

- (a) An applicant who is eligible under (ii), (iii) and (iv) above could be considered for appointment only if applicants qualified under (1) above are either not available or evaluated and considered as unsatisfactory by the Selection Committee. Such appointment would require a special justification and approval of the University Grants Commission.
- (b) All Lecturers (Probationary) shall complete an induction training course (which includes Teaching/Learning Methodologies) within a period of one year from the date of first appointment. This is a pre-requisite for probationary study leave and confirmation in the Post. The University Grants Commission will organize this course.

- 2) MD with Board Certification of the Postgraduate Institute of Medicine (PGIM) or its equivalent

Or

A Doctoral Degree in the relevant field

Or

A Masters Degree in the relevant field with full time research of at least 24 months duration

AND

- 3) At least eleven (11) years experience of which not less than six (06) years should have been after obtaining qualifications stipulated in (2) above in one or more of the following:
- i. Teaching at University Level,
 - ii. Professional experience,
 - iii. Research in a recognized Institution,
 - iv. Postgraduate Studies

(F) Senior Lecturer Grade II

- 1) Candidates who are applying for above post should possess academic qualifications required for Lecturer (Probationary)

AND

- 2) MD with Board Certification of the Postgraduate Institute of Medicine (PGIM) or its equivalent

Or

A Doctoral Degree in the relevant field

Or

A Masters Degree in the relevant field with full time research of at least 24 months duration

AND

- 3) At least six (06) years' experience in one or more of the following;
- I. Teaching at University Level,
 - II. Professional experience,
 - III. Research in a recognized Institution,

(G) Lecturer (Unconfirmed)

- 1) Candidates who are applying for above post should possess academic qualifications required for Lecturer (Probationary).

And

- 2) * MD & awaiting Board Certification of the Postgraduate Institute of Medicine

Or

* A Doctoral Degree in the relevant field

Or

* A Masters Degree in the relevant field with full time research of at least 24 months duration

Notes:

- a) An applicant who qualifies for Lecturer (Probationary)(Medical/Dental) as per category (03) of post No. 01 of Commission Circular No.721 as amended, may be exempted from (2) above if he/she has a MD/MS & Board Certification of the PGIM or a Doctoral Degree, in the relevant field.

A Lecturer (Unconfirmed) (Medical/Dental), who has completed the three year period of satisfactory service and the induction training course within a period of one year from the date of appointment and also within a period of one year from the date of appointment and also obtained Board Certification of the PGIM, may be confirmed in the post of Lecturer (Medical/Dental) provided such lecturer has fulfilled all other requirements specified in the letter of appointment.
2. The Confirmed Lecturer (Medical/Dental) may be considered for promotion to Senior Lecturer Grade II upon fulfilling 5 years of experience (along with the experience as defined under (3) of post No. 04) and satisfying the other requirements as specified in the Scheme of Recruitment under Post No. 05 of Commission Circular No.721.
3. The effective date of the promotion to the post of Senior Lecturer Grade II of only those appointed as Lecturer (Unconfirmed) (Medical/Dental)] based on a MD/Doctoral degree, may be backdated to the effective date of Board Certification of the PGIM or to the date on which they have completed 6 years of experience as per Post No 04, whichever occurs later, as applicable, by placing them on the relevant salary step, with no back wages being paid.

NOTES:

- I. Candidates who are eligible under category H (1) above will be interviewed and evaluated first.
- II. Candidates who are eligible under Category H (2) and H (3) above could be invited for an interview only if applicants qualified under category H (1) above are either not available or found to be unsuitable by the Selection Committee after interview and evaluation. Appointment of Candidates under Categories H (2) and H (3) would require the approval of the University Grants Commission.
