4. Method of selection	Applicants who have fulfilled requirements will be called for written competitive examination. Based on the results of the above mentioned written competitive examination, eligible candidates will be called for an interview. Interview will be held to scrutinize the certificates and to check physical condition of the candidates.
5. Place of Work	Ceylon Electricity Board reserves the right to post the Electrical Superintendent / Mechanical Superintendent recruited to any location/s in the country decided by the CEB. Selected applicants will only be recruited if they in writing agree to accept the post at the location decided by the CEB
