# VACANCY

## Vacancy for the General Manager Water Resources Board - 2025

Applications are invited from citizens of Sri Lanka for the General Manager vacancy which were approved by the Department of Management Service.

### 1. General Manager (HM 2-1)

#### Qualification External Candidates (1 or 2 below)

1. A Bachelor's degree in Science/Engineering/Business Administration/Public Administration or any other degree relevant to the subject area of the post, which is recognized by the U.G.C.

AND

A Postgraduate Degree (Master's) in Science/Engineering/Business Administration/Public Administration or any other degree relevant to the subject area or corporate Membership of a recognized professional chartered institution which is relevant to the subject area of the post.

WITH

At least 20 years' experience at Managerial Level out of which 05 years of experience should be at Senior Managerial Level with a proven track record in a Corporation, Board or a reputed Mercantile Establishment after obtaining the first degree.

2. A Bachelor's degree in Science/Engineering/Business Administration/Public Administration or any other degree relevant to the subject area of the post, which is recognized by the U.G.C.

AND

PhD Degree relevant to the subject area of the post.

AND

At least 05 years' experience at Senior Managerial Level with a proven track record and Management experience in a Corporation, Board or a reputed Mercantile Establishment after obtaining PhD.

#### Internal Candidates

: A minimum of 02 (two) years satisfactory service in a Deputy General Manager post (HM 1-3) or 05 (five) years satisfactory service in an Assistant General Manager post (HM 1-1) in Water Resources Board in the subject area relevant to the post.

AND

A proven ability to lead and direct multi-disciplinary teams. Experience in proper deployment and efficient management of human and other resources.

**Age** : Should be not less than 35 years and not more than 55 years. The upper age limit will not apply to the internal candidates

#### General Conditions:

1. Applicants must complete the above qualifications before the closing date for applications.
2. Applicant should be a Citizen of Sri Lankan.
3. Salaries will be paid according to the Management Service Department Circular No. MSD/1/2025 issued by Management Service Department.
4. Government approved cost of living allowance, Professional allowance, Transport allowance or Transport facility and Fuel allowance, with other Government approved allowances.
5. Age limit stipulated above does not apply for employees in the Public/Semi Government Sector.
6. Applications from employees in the Public Sector should be forwarded through the Head of the Department of the Institution.
7. The title of the post applied for should be stated on the left-hand corner of the envelope.
