## VACANCY ANNOUNCEMENT

Government of Sri Lanka has decided to establish a Trade National Single Window System as a single entry point for submission of documents and data requirement by the traders on their cross border trade flows (Imports, Exports and Transshipment) to the Border Trade Regulatory Agencies. The result of such process shall also be notified to the traders through the automated Trade National Single Window System.

Accordingly, the Ministry of Finance, Planning and Economic Development established a dedicated Project Implementation Unit (PIU) to implement the proposed Trade National Single Window System. Hence, applications are hereby invited from the most eligible candidates to fill the following positions of the PIU of the Trade National Single Window System Project.

#### Senior ICT Specification Officer – Development. (PS 5) - (01 Position) <u>Qualifications & Experience</u>

- A Bachelor's degree in computer science, Information Technology, or a related field which is recognized by the University Grant Commission; **or**
- A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in relevant field; **or**
- Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 7- issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission in a field related to the above post; and
- At least 03 years of experience in a related post.

#### OR

- Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 6- issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission in a field related to the above post; and
- At least 08 years of experience in a related post.

#### OR

- Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 5- issued by a Technical / Vocational Training Institute accepted by Tertiary and Vocational Education Commission in a field related to the above post; and
- At least 13 years of experience in a related post.

# 2) Stakeholder Communication & Marketing Officer. (PS – 6A) – (01 Position) <u>Qualifications & Experience</u>

- A Bachelor's degree in Communication, Marketing or a related field which is recognized by the University Grant Commission, **or**
- A qualification recognized by the University Grant Commission as an equivalent qualification to the degree in the relevant field, **or**
- Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 7, issued by Technical/Vocational Training Institute accepted by Tertiary and Vocational Education Commission for Communication and Marketing Field; and
- At least 1 year of experience in a related post.

#### OR

- Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 6, issued by Technical/Vocational Training Institute accepted by Tertiary and Vocational Education Commission for Communication and Marketing filed; and
- At least 6 years of experience in a related post.

#### OR

- Having obtained a certificate of proficiency not below than the National Vocational Qualification Level 5 issued by Technical/Vocational Training Institute accepted by Tertiary and Vocational Education Commission for Communication and Marketing Field; and
- At least 11 years of experience in a related post.

- Bachelor's degree in Business, Economics, Supply Chain Management, Public Administration from any institution, recognized by the University Grants Commissions; or
- A qualification recognized by the University Grants Commission as an equivalent qualification to the degree in relevant field. **or**
- Having completed an Advance Certificate Course in Public Procurement and Assets Management or any other Diploma in Procurement from an accredited institution; and
- Minimum 05 years of experience in contract management, procurement operations, or advising on contract administration and execution (for a government agency preferred).
- Extensive experience to liase with donor agencies (World Bank, ADB etc..)
- Proficiency in using additional MS Office products and tools.
- Sound knowledge and understanding on the contracts laws and regulations applicable in Sri Lanka context;
