Method of Recruitment

Software Developer :- Selection will be made by a followed by structured Interview

Instructor / IT Assistant:- Selection will be made by a followed by structured Interview, written / practical Examination

Nature of the Appointment

This is a permanent appointment and the selected officer is entitled to the benefits of Employees' Provident Fund and Employees' Trust Fund.

Every Candidate:-

- 1. Should be a citizen of Sri Lanka
- Should be not less than 18 years and not more than 45 years of age. However the maximum age limit will not be applicable to the internal applicants.
- 3. Should have the mental and physical fitness to perform the duties entrusted to the post properly
- Should be a permanent resident of the Western Province. Further the applicant should prove the residence within Western Province for a period of 03 years as at the closing date of application.
- 5. Should be with excellent moral character

Method of Applications:-

- i) Applications should be sent by registered post along with the copies of relevant certificates to reach before 30.07.2025 and the post applied for should be written on the top left corner of the envelope which contains the application. Applications which are sent without copies of relevant educational /professional qualifications will be rejected without any notice.
- ii) Applicants, who are already serving in Government Departments, Statutory Boards or State Corporations, should submit their applications through the respective Heads of Institutions. The Head of Institution should have certified that the applicant will be released from the service within a month, if he/she is selected to the post.
- iii) Further the applicants, who have applied under (a) with qualification other than the NVQ 05 above, should submit a letter issued by the Tertiary and Vocational Education Commission to the effect that the other qualifications

mentioned by the applicant are equivalent to the Level 05 of NVQ.
