The Integrated Watershed & Water Resources Management Project (IWWRMP) is a World Bank-funded Project under the Ministry of Agriculture, Livestock, Lands and Irrigation, expected to be completed by 31<sup>st</sup> October 2026.

Applications are hereby invited from citizens of Sri Lanka for the post of **Environment Specialist (PS3 level)** at the Project Management Unit in Colombo. The position is on a full-time **contract basis**, in accordance with Management Services Department (MSD) Circular No. 01/2019 and government recruitment procedures.

## Required Qualifications & Experience;

- I. A successfully completed Bachelor's Degree in the relevant field, which is recognized by the University Grants Commission (UGC) Or a qualification recognized by the UGC as an equivalent qualification to the degree in the relevant field Or an Associate membership / a similar professional qualification obtained from a recognized professional institution in the relevant field with at least 10 years post qualifying experience at a Managerial Level.
- II. A successfully completed Bachelor's Degree in the relevant field, which is recognized by the UGC Or a qualification recognized by the UGC as an equivalent qualification to the degree in the relevant field Or an Associate membership / A similar professional qualification obtained from a recognized professional institution in the relevant field And a Postgraduate Degree in the relevant field or Corporate / Chartered membership or a similar professional qualification obtained from a recognized professional institution in the relevant field With at least 08 years Post qualifying experience in managerial level.
- III. Class I Officer of a Government All Island Service or similar status in the relevant field with at least 03 years of experience in the Class I post.

NOTE: A minimum of 3 years' experience in World Bank or other foreign-funded projects, specifically in Procurement, Environmental, and Social Sectors, is essential.

- 7. Must be willing to work extended hours and on weekends when required.
- 8. A proven record of good conduct and professional relationships with superiors throughout their career is required.
