- Applicants should not suffer from diseases or chronic medical conditions (tuberculosis, hepatitis, syphilis, and gonorrhea, AIDS or mental illness).
- Should be submit clean police report in Sri Lanka & should not have any history of drug or alcohol abuse. If you are worked in any country over 6 months need to submit the police report from the relevant country as well.
- Applicants should pass the year 10 of schooling. 7. Should have basic knowledge of English. 8.

- Should have two years experience in the infrastructure relevant categories except Operators of machinery and heavy equipment. 10. Selected candidates should agree to undergo all medical & other requirements for entry
- into & stay in Israel as required by Israeli authorities.

The worker's estimated gross salary, before permitted deduction and taxes, shall not be
