



Tertiary and Vocational Education Commission – VACANCIES

(Ministry of Education, Higher Education and Vocational Education)



The Tertiary and Vocational Education and Commission (TVEC), established under the Tertiary Education and Vocational Education Act, No. 20 of 1990 and re-established as a statutory body under the (Amendment) Act, No. 50 of 1999, is a national regulatory body responsible for policy implementation, planning, coordination, quality assurance and accreditation in the Technical and Vocational Education and Training (TVET) sector of Sri Lanka.

Applications are invited from eligible persons for the vacant positions in the TVEC.

The officers selected for these positions must be qualified to serve in any division of the Commission.

1. Deputy Director General (HM 2-1)
