## IDENTITY ACCESS MANAGEMENT (IAM) / PRIVILEGE ACCESS MANAGEMENT (PAM) ADMINISTRATOR

The Identity Access Management (IAM) / Privilege Access Management (PAM) Administrator is responsible for implementing, and managing the organization's IAM solutions to secure privileged accounts and access and reports to the Chief Information Security Officer (CISO). This role ensures robust protection against unauthorized access, supports compliance with regulatory requirements, and mitigates risks associated with privileged credentials.

### RESPONSIBILITIES

- Develop and maintain IAM /PAM policies aligned with standards (e.g., NIST 800-53, ISO 27001, and PCI-DSS).
- Configure and manage IAM/PAM tools to secure privileged accounts across on-premises, cloud, and hybrid environments.
- Oversee credential lifecycle management, including discovery, onboarding, rotation, and secure storage of privileged credentials.
- Investigate and respond to IAM/PAM -related security incidents, such as credential misuse or unauthorized access attempts.
- Recommend improvements to IAM/PAM controls based on incident findings.
- Assist in audits by providing IAM/PAM documentation, access logs, and control evidence.
- Ensure privileged accounts comply with regulatory and Bank requirements.
- Implement just-in-time access, session monitoring, and MFA for privileged accounts.
- Enforce least privilege principles by defining and reviewing access policies for privileged users and systems.
- Work with IT, and application teams to integrate IAM/PAM solutions with existing infrastructure.
- Monitor and audit privileged account activities, analyzing logs for unauthorized access or anomalies.
- Generate reports on IAM/PAM usage, compliance, and security events for leadership and audits.

### ELIGIBILITY CRITERIA

- Candidate should be a citizen of Sri Lanka.
- Possess a Bachelor's degree or Master's degree in Information Security /Information Technology by a university or a degree awarding institute recognized by the University Grants Commission of Sri Lanka.
- Minimum 2 years' experience in information security, with a focus Identity and Privilege Access Management.
- Hands-on experience with IAM/PAM tools (e.g. CyberArk, Entra, Beyond Trust Delinea, Senhasegura)
- Strong understanding of data protection regulations and frameworks (e.g., PCI-DSS, PDPA, ISO 27001).
- Sound knowledge on understanding of industry trends, emerging technologies & threats and specific threats targeting financial institutions.
- Possess excellent analytical and problem solving skills.

### AGE

Preferably below 45 years of age as at closing date of applications.

### METHOD OF SELECTION

Shortlisted applicants based on the stipulated qualifications and experience will be called for an interview. The appointment will be made on contract basis and performance will be evaluated annually.
