3.	Management Assistant Gr. III	(As per UGC Commission Circular No. 06/2018 and 06/2018[ii])  1. Should have passed the G.C.E. (O/L) Examination in six (06) subjects at one sitting with credit passes in:  i. Sinhala Language/ Tamil Language  ii. English Language/ English Literature
		iii. Mathematics AND
		AINU

		2. Should have passed in all subjects at G.C.E (A/L) examination
		(except the Common General Paper) at one sitting.
		(Passing in 03 subjects under the old syllabus at one sitting would
		be sufficient for this purpose.)
		3. Preference will be given to those who possess the following;
		a) An acceptable qualification in computer applications of not
		less than six (06) months duration obtained from a
		recognized institute.

		b) Two years of experience in the use of computer application
		packages.
