SECURITY ARCHITECT

The Security Architect will be a key leader in defining, designing, and implementing the security architecture for People's Bank systems, applications, and infrastructure. This role requires a deep understanding of security best practices, emerging threats, and regulatory compliance. The Security Architect will collaborate with cross-functional teams to ensure that security is integrated throughout the development lifecycle and operational processes, ultimately safeguarding the Bank's assets and data.

RESPONSIBILITIES

- Define Information security standards, policies, and procedures and ensure their consistent implementation across the software development teams.
- Develop and maintain a comprehensive security architecture framework that aligns with business objectives, risk appetite, and regulatory requirements (e.g., ISO 27001, GDPR, PCI DSS, local data protection laws in Sri Lanka if applicable).
- Design secure solutions and patterns for cloud, on premise, and hybrid environments, considering aspects like network security, application security, data security, identity and access management, and endpoint security.
- Participate in the design and review of new and existing systems and applications to ensure security requirements are integrated from the outset (Security by Design).
- Provide security guidance and expertise to development, operations, and other IT teams during the implementation of security controls.
- Guide and Implement secure development practices to Software Development team.
- Assist in the selection and deployment of security tools and technologies.
- Define secure configuration standards for various platforms and technologies.
- Conduct threat modeling exercises to identify potential vulnerabilities and attack vectors in systems and applications.
- Collaborate effectively with cross-functional teams, including development, operations, networking, and business units.
- Providing security clearances for systems moving to production.

- Possess a Bachelor's degree or Master's degree in Information Security or Information Technology specialized in Information Security by a university or a degree awarding institute recognized by the University Grants Commission of Sri Lanka.
