Age should be not less than 18 years and not more than 45 years. The upper age limit will not apply to internal candidates.

General Conditions: -

- ❖ 8% of the salary has to be contributed to the Employees' Provident Fund and the Welfare Benefits Board will pay 12% as government contribution. Further, a contribution of 3% to the Employees' Provident Fund is paid by the Welfare Benefits Board.
- ❖ Appointments will be made purely in the order of merit at the interview.
- ❖ These positions are permanent. The posts are subject to a probationary period of 03 years before being made permanent.
