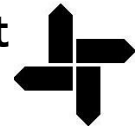

1. Post : Chief Engineer (Project)

Qualification for External Candidates:

B.Sc. Engineering Degree in the relevant field which is recognized by the University Grant Commission (UGC).

AND

A Chartered Engineer with Corporate Membership (relevant field) of the Institution of Engineers Sri Lanka (IESL) or any other Institution recognized by the Institution of Engineers Sri Lanka (IESL) and registration in Engineering Council Sri Lanka (ECSL) as a Chartered Engineer.

WITH

Minimum of 13 years' experience at a "Managerial Level" in a corporation, Statutory Board / Institution or a reputed private institution.

2. Post : Quantity Surveyor

Qualification for External Candidates: (i or ii below)

- i. B.Sc. Degree in Quantity Surveying which is recognized by the UGC.

WITH

A Minimum of one (01) year post qualifying experience in the relevant field to the post after obtaining the first degree.

- ii. A Graduate member of the Institute of Quantity Surveyors Sri Lanka (IQSSL).

WITH

A Minimum of one (01) year post qualifying experience in the relevant field to the post after obtaining the first degree.

3. Post : Technical Officer

Qualification for External Candidates: (i or ii below)

- i. Having obtained a certificate of proficiency in the field relevant to the subject area not below than the National Vocational Qualification Level 5, issued by a Technical/ Vocational Training Institute accepted by the Tertiary and Vocational Education Commission.

WITH

At least One (01) year post qualifying experience in a relevant field in a Corporation, Board or a Reputed Statutory Institution.

- ii. Having obtained a certificate of proficiency in the field relevant to the subject area not below than the National Vocational Qualification Level 6, issued by a Technical/ Vocational Training Institute accepted by the Tertiary and Vocational Education Commission.

4. Post : Draughtsman

Qualification for External Candidates: (i or ii below)

- i. Having obtained a certificate of proficiency in the field relevant to the subject area not below than the National Vocational Qualification Level 4, issued by a Technical/ Vocational Training Institute accepted by the Tertiary and Vocational Education Commission.

WITH

Three (03) years working experience in the relevant field in a recognized Institution.

- ii. Having obtained a certificate of proficiency in the field relevant to the subject area not below than the National Vocational Qualification Level 5, issued by a Technical/ Vocational Training Institute accepted by the Tertiary and Vocational Education Commission.

5. Post : Laboratory Assistant

Qualification for External Candidates:

Having obtained proficiency certificate not below than the National Vocational Qualification Level 2, issued by a Technical Vocational Training institute accepted by the Tertiary and Vocational Education Commission, relevant to the function of each post.

Every Applicant,

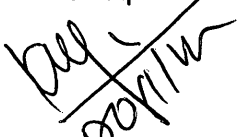
- i. Should be a citizen of Sri Lanka.
- ii. Should be physically and mentally fit to discharge the duties of the post well and to serve in any part of the Island.
- iii. Should be of excellent moral character.

❖ **Submission of the Application:**

Duly completed applications along with educational (with degree transcript), professional qualifications and service experience certificates should be sent to Deputy Director General (Human Resource Management & Administration), Road Development Authority, "Maganeguma Mahamedura", 1st Floor, No. 216, Denzil Kobbekaduwa Mawath, Koswatta, Battaramulla on or before 07.12.2025 and the post applied for should be clearly indicated on the top left corner of the envelope.

❖ **General Conditions applicable to the post:**

- Employees' Provident Fund contribution by the Authority is 12% against 8% by the Employees plus additional contribution of 3% towards Employees' Trust Fund.
- Applicant working in the Govt. Departments / state corporations / statutory boards & Authorities should send their applications through the respective heads of the institution / organization.
- Name, address and telephone numbers of two non-related referees should be stated in the application to obtain verifications of the applicant.
- The Qualifications mentioned in the application itself and the relevant certificates such as professional, educational (with relevant transcript) & service experience certificates etc. annexed with the application should be considered only for short listing the applications and selection process.
- Applications that are not properly filled in accordance with the given format and non-submission of photocopies of relevant certificates together with the application will be rejected.
- Appointments will be made purely in the order of merit at the interview.
- All the above appointments will be effective for a period of one year from the date of appointment.
- The officers to be selected to serve on contract basis are not eligible to claim any permanent appointment in the Road Development Authority.
