4. FACULTY OF MEDICINE

(i) Department of Anatomy

(a) Senior Lecturer Grade I/ Senior Lecturer Grade II

The candidate should possess a MBBS degree with a completed postgraduate research degree (should be relevant to the field of Anatomy) or a Clinical degree (MD/MS) in any field of Surgery, Radiology, or Histopathology.

(b) Lecturer (Unconfirmed)

The candidate should possess a MBBS degree with a completed postgraduate degree (should be relevant to the field of Anatomy) or a Clinical (MD/MS) degree in any field of Surgery, Radiology or Histopathology, and awaiting Board Certification.

(c) Lecturer (Probationary)

Non-Medical: B.Sc. special degree in Chemistry/Biochemistry/ Molecular Biology with Honours.

(iii) Department of Community Medicine

(a) Senior Lecturer Grade I/ Senior Lecturer Grade II/ in Family Medicine

Candidates should have a MD (Family Medicine) with Board Certification as a specialist family physician.

(b) Lecturer (Unconfirmed) in Family Medicine

Candidates should have MBBS or equivalent with Honours and MD (Family Medicine) awaiting Board Certification.

(c) Lecturer (Probationary) in Family Medicine

Candidates should have MBBS or equivalent with Honours, registrable/registered in SLMC as a medical practitioner. Being a postgraduate trainee in Family Medicine would be an advantage.

(iv) Department of Forensic Medicine

(a) Senior Lecturer Grade I/ Senior Lecturer Grade II

Candidates should have a MBBS or equivalent degree, with a postgraduate qualification of MD (Board-Certified) in Forensic Medicine.

(b) Lecturer (Unconfirmed)

Candidates should have MBBS or equivalent degree with a postgraduate qualification of MD in Forensic Medicine, awaiting Board Certification.

(c) Lecturer (Probationary)

Candidates should have a MBBS or equivalent qualification with Honours, which is registerable in the Sri Lanka Medical Council (SLMC) as a medical practitioner.

(v) Department of Physiology

(a) Senior Lecturer Grade I/ Senior Lecturer Grade II

MBBS degree, with postgraduate qualifications PhD, MPhil, MD (Board-Certified) in a field related to Medical Physiology.

(b) Lecturer (Unconfirmed)

Candidates should have MBBS or equivalent degree with a postgraduate qualification of MD in a field related to Medical Physiology (awaiting Board Certification).

(c) Lecturer (Probationary)

Candidates should have a MBBS or equivalent qualification with Honours, which is registerable in the Sri Lanka Medical Council (SLMC) as a medical practitioner.

(vi) Department of Microbiology

(a) Senior Lecturer Grade I/ Senior Lecturer Grade II

Candidates should have MBBS or equivalent degree with a postgraduate qualification of MD in Medical Microbiology or Medical Virology with Board Certification.

(b) Lecturer (Probationary)

Candidates should have a MBBS or equivalent qualification with Honours, which is registerable in the Sri Lanka Medical Council (SLMC) as a medical practitioner.

The Lecturer (Probationary) should be willing to complete postgraduate training in PGIM, University of Colombo, Sri Lanka, in Medical Microbiology or Medical Virology if recruited.

(c) Lecturer (Unconfirmed)

Candidates should have MBBS or equivalent degree with a postgraduate qualification of MD in Medical Microbiology or Medical Virology (awaiting Board Certification).

(vii) Nuclear Medicine Unit

(a) Senior Lecturer Grade I/ Senior Lecturer Grade II in Nuclear Medicine

Candidates should have MD in Chemical Pathology/Genetics/ Pediatrics / Endocrinology or PhD in Genetics/ Laboratory Medicine/ Molecular Biology or equivalent qualification.

(b) Lecturer Unconfirmed in Nuclear Medicine

Candidates should have MBBS or equivalent with Honors and MD in above mentioned fields awaiting board certification or Ph.D in the above-mentioned fields with a pending thesis defense.

(c) Probationary Lecturer in Nuclear Medicine

Candidates should have MBBS with Honors, be registered with SLMC, or a B.Sc. with a special degree with Honors in Molecular Biology and Biotechnology or Medical Laboratory Science.

(viii) Department of Psychiatry

(a) Professor/Senior Professor of Psychiatry (Chair)

MD in general adult Psychiatry or any other subspecialty in Psychiatry approved by the board of study in Psychiatry of PGIM, with Board Certification as a specialist, shall be considered for the qualification and the specialization to be eligible to apply and recruit to the post of Chair Professor.

MBBS with Honours, fully registered/ registrable in the Sri Lanka Medical Council (SLMC) as a medical practitioner.

Should be able to follow postgraduate training in Anaesthesiology with special training in critical care.

Being a Postgraduate trainee in Anaesthesiology with special training in critical care would be an advantage.

(x) Department of Parasitology

(a) Senior Lecturer Grade I

MBBS or an equivalent degree and a Ph.D in Parasitology or MD in Community Medicine, Medicine or Paediatrics with Board Certification. Candidates should possess at least eleven years of experience, including five years' experience after a postgraduate degree.

(b) Senior Lecturer Grade II

MBBS or an equivalent degree and a Ph.D in Parasitology or MD in Community Medicine, Medicine or Paediatrics with Board Certification. Candidates should possess at least six years of experience, including one year of experience after a postgraduate degree.

(c) Lecturer (Unconfirmed)

MBBS or an equivalent and Diploma in Medical Microbiology or MSc in Parasitology, Public Health, and Community Medicine or Registrars in Community Medicine, Medicine, Paediatrics.

(d) Lecturer (Probationary)

MBBS with Honours, fully registered/ registrable in the Sri Lanka Medical Council (SLMC) as a medical practitioner.

(xi) Department of Pathology

(a) Senior Lecturer Grade I/ Senior Lecturer Grade II in Pathology

MD in Chemical Pathology with Board Certification as a specialist in Chemical Pathology.

(b) Lecturer (Probationary) in Pathology

MBBS or equivalent degree with Honours, and/or with 3rd MBBS Honours registrable/fully registered in SLMC as a medical practitioner, should be able to follow postgraduate training in Chemical Pathology. Being a postgraduate trainee in Chemical Pathology would be an advantage.

(c) Lecturer (Unconfirmed) in Pathology

MD in Chemical Pathology without Board Certification.

(xii) Department of Pharmacology

(a) Professor /Senior Professor of Pharmacology (Chair)

Candidate should have a MBBS degree with a postgraduate qualification of Ph.D in a Pharmacology-related field or MD in Medicine approved by the board of study in PGIM with Board Certification as a specialist, with a sound academic background and experience.

(b) Senior Lecturer Grade I/ Senior Lecturer Grade II

Candidates should have a MBBS degree, with a postgraduate qualification of Ph.D. or M.Phil or MD (Board Certified) in Pharmacology pharmacology-related field.

(c) Lecturer (Unconfirmed)

Candidates should have a MBBS degree with MD (awaiting Board Certification) in a Pharmacology-related field.

(d) Lecturer (Probationary)

Candidates should have MBBS degree with honors, registrable/fully registered in SLMC as a medical practitioner.

Candidates should have MBBS or equivalent with a postgraduate certification of MD and be Board-Certified as a specialist in Surgery.

(c). Lecturer (Probationary)

MBBS or equivalent degree with Honours, which is registerable in the Sri Lanka Medical Council (SLMC) as a medical practitioner.
