The University of Kelaniya will entertain applications from suitably qualified persons for the following posts up to **23rd January 2026**.

01. Post : Book Binder (Grade III)

Salary Method : UPL 3 (III) Rs. 48,005 – 16 x 490 – 55,845 (as at 01.01.2027)

(Approximate initial monthly gross salary including other allowances will be Rs. 80,798/=)

Age Limit : Age should be not less than 18 years and not more than 45 years.

02. Post : Fitter (Grade III)

Salary Method : UPL 3 (III) Rs. 48,005 – 16 x 490 – 55,845 (as at 01.01.2027)

(Approximate initial monthly gross salary including other allowances will be Rs. 80,798/=)

Age Limit : Age should be not less than 18 years and not more than 45 years.

03. Post : Driver (Grade III)

Salary Method : UPL 3 (III) Rs. 48,005 – 16 x 490 – 55,845 (as at 01.01.2027)

Age Limit : Age should be not less than 18 years and not more than 45 years.

04. Post : Tractor Operator (Grade III)

Salary Method : UPL 2 (III) Rs. 44,575 – 16 x 490 – 52,415 (as at 01.01.2027)

(Approximate initial monthly gross salary including other allowances will be Rs. 76,674/=)

Age Limit : Age should be not less than 18 years and not more than 45 years.

05. Post : Nurse – (Contract – Two Years)

Rs. 51,095/= (Basic Salary) + Other approved allowances.

Age Limit : Not more than 45 years.

Persons disqualified from appointment to any post in the Commission/ Higher Educational Institutions/Institutes

A Person:

- (a) who has been compulsorily retired for general inefficiency or retired as a merciful alternative to dismissal or whose services have been terminated or dismissed for disciplinary reasons after a formal inquiry;
- (b) who has vacated post while in the State Service or in the service of a Public Corporation or Statutory Board or in the service of the Commission or any Higher Educational Institution/ Institute;
- (c) who has been convicted by a Court of Law for a criminal offence committed against the Democratic Socialist Republic of Sri Lanka;
- (d) who has been convicted by a Court of Law in any Criminal proceedings or convicted by a Court of Law, after summary inquiry in terms of Section 449 of the Criminal Procedure Code;
- (e) who had been declared as bankrupt, should not be appointed to any post in the Commission or in any Higher Educational Institution / Institute. However, under exceptional circumstances those who are in categories (a) and (b) above may be considered for appointment with prior approval of the Commission.

Persons who are not citizens of Sri Lanka should not be appointed to any post in the Commission/ Higher Educational Institutions/ Institutes.

Applicants from higher education institutions, Government Departments, Corporations and Statutory Boards should channel their applications through the respective Heads of Institution.

The University reserves the right to shortlist the candidates and / or not to recruit all the above positions or any of them due to a reason satisfied by Council. The decision of the Council would be the final in this regard.

Applications which do not meet the required qualifications, relevant qualification certificates not attached, incomplete, illegible and received after the closing date will be rejected.
