Applications are invited from citizens of Sri Lanka for the following posts that exist at the Development Lotteries Board.

01. Recruitment for the Post of Assistant General Manager (Finance)

Name of Post : Assistant General Manager (Finance) – Grade II
No. of Posts : 01
Salary Code : MM 1-1

Basic Salary Paid for year 2026 : Rs. 81,710/=

(Salary Scale specified for this post as per the Provisions of the Management Services Circular 01/2025 is Rs. 91,690 – 10 x 2480 – 15 x 3450 – 168,240 and will be installed in the initial salary step of Rs. 91,690/- from 01.01.2027)

- There is a possibility of earning about Rs. 180,000/- per month and it will vary from month to month

1(a) Educational and Professional Qualifications:

For the recruitment of external applicants (01 or 02 below)

- (01) Should have obtained a degree in Accountancy / Business Administration / Commerce / Management or in a similar subject field recognized by the University Grants Commission.

And

Should have at least five (05) years service experience in a management level post in the relevant field in Government, Government Corporation, Board, Statutory Institution or in a reputed private sector institution after obtaining the degree

- (02) Should have obtained the Full membership of a recognized Chartered Professional Institute in Accountancy / Management Accountancy or compatible to similar subject field and should have at least five (05) years service experience in a management level post relevant to the subject field after obtaining the qualification.

(Example: Institute of Chartered Accountants of Sri Lanka (ICASL) / Association of Certified Chartered Accountants (ACCA), Chartered Institute of Management Accountants (CIMA))

Recruitment of Internal Applicants (1 or 2 below)

- Staff Members who have fulfilled the qualifications of External Applicants mentioned above in 1(a).
- Should have completed a satisfactory service period of at least five (05) years in the subject field relevant to this post in Junior Management (JM) Service Category.

02. Recruitment for the Post of Chief Security Officer

(Salary Scale specified for this post as per the Provisions of the Management Services Circular 01/2025 is Rs. 72,650 – 10 x 1360 – 18 x 2040 – 122,970 and will be installed in the initial salary step of Rs. 72,650/- from 01.01.2027)

- There is a possibility of earning about Rs. 150,000/- per month and it will vary from month to month

Educational and Professional Qualifications:

Recruitment of External Applicants (01 or 02 or 03 below)

- (1) Degree recognized by the University Grants Commission with three (03) years post qualification service experience in a Staff Officer Level post of the Government Security Division

Or

- (2) Being an Officer who has formally retired from regular force in tri forces after having served in the post of Major or above

Or

- (3) Being an Officer who has formally retired from the regular service of Sri Lanka Police after having served in the post of Assistant Superintendent of Police or above

(Salary Scale specified for this post as per the Provisions of the Management Services Circular 01/2025 is Rs. 53,940 – 10 x 800 – 11 x 1190 – 10 x 1320 – 5 x 1350 – 94,980 and will be installed in the initial salary step of Rs. 53,940/- from 01.01.2027)

- There is a possibility of earning about Rs. 130,000/- per month and it will vary from month to month

Educational and Other Qualifications (For External and Internal Applicants)

Should have obtained a degree relevant to the Information Technology field recognized by the University Grants Commission and should have one (01) year's service experience in the relevant field.

Ability to fulfill the undermentioned abilities / skills is anticipated from the candidates applying for the three (03) posts of Information Technology Assistant

3(a) Information Technology Assistant – Software Development

The selected candidate should be a competent Software Developer who can effectively perform software development activities and contribute to end-to-end system development. The ability to work as a Full-Stack Developer within the institution is expected for this post.

Strong knowledge of programming languages and the ability to work in an agile development environment are essential. Experience in at least two of the following programming languages is anticipated: Java, PHP, Python, JavaScript, or C#.

In addition, the candidate should have a good understanding and practical knowledge of modern software frameworks, database technologies, and CI/CD pipelines. Familiarity with AI/ML basic concepts (such as AI-based automation, data processing, or intelligent features) and a basic understanding of integrating AI capabilities into software solutions will be considered an additional advantage.

3(b) Information Technology Assistant – Network & System Administration

The selected candidate should be a capable System and Network Engineer who can support the installation, operation, maintenance, and management of the organization's IT infrastructure, including both network and system environments.

The role requires the ability to manage Windows and Linux servers, network devices such as switches, routers, firewalls, and wireless systems, as well as virtualized environments. The candidate should also be able to monitor system performance, security logs, backups, and network traffic to ensure stability and continuity of services.

Good knowledge in Windows Server and Linux administration, TCP/IP, DNS, DHCP, VLAN, VPN, Active Directory, virtualization platforms (VMware / Hyper-V), and network security is expected. Practical experience in firewall management, scripting for automation (PowerShell / Bash / Python), CI/CD environments, and enterprise-level antivirus solutions will be considered an additional advantage.

3(c) Information Technology Assistant – Information Security

The selected candidate should be able to support the organization's Information Security functions and handle basic to intermediate-level security operations as required for this post. The role involves supporting the implementation and enforcement of information security policies, procedures, and standards within the institution.

Key responsibilities include supporting risk assessments, vulnerability assessments, and penetration testing activities, as well as assisting with the administration and supervision of SIEM systems and the monitoring and analysis of security logs. The candidate is also expected to support incident response activities, assist in forensic processes, and contribute to investigations related to security violations and cyber incidents.

In addition, the candidate should support compliance and alignment with ISO 27001, PDPA, and other applicable regulatory and governance standards. Responsibilities also include contributing to security awareness programmes, phishing simulation campaigns, identity and access management (IAM) processes, and user privilege review activities.

The candidate should have strong basic knowledge of cyber security principles and security frameworks, along with awareness of security technologies such as EDR/XDR, email security gateways, and web application firewalls (WAF). Knowledge of network security devices including firewalls, IDS/IPS, and VPN technologies is expected. Familiarity with vulnerability assessment and security testing tools such as Nessus, Burp Suite, and other security scanning tools will be considered an additional advantage, along with basic knowledge of SOAR platforms, encryption, PKI, certificate management, incident response, and digital forensics.

General Requirements (Applicable to All IT Assistant Posts) :-

Applicants should possess strong analytical and problem-solving skills, excellent communication skills, and the ability to work effectively as part of a team. Candidates should also demonstrate a willingness to learn new technologies and the ability to adapt to changing environments.

Recruitment will be made on selection based on the results of (vocal / written or practical test) a competitive examination and / or at the structured interview conducted by a board appointed by the Competent Authority after calling for applications by a Gazette notice or newspaper advertisement as decided by the Board of Directors of the Institution. (Method of giving marks for the qualified applicants at the interview will be notified before the interview.)

Speaking, writing and understanding skills in English language is required as per the nature of the duties and that will be tested at the interview.
