Hard copies of the downloaded applications with original signatures and rubber stamps, uploaded certificates and Form A should be sent to reach Senior Assistant Registrar, Academic Establishments Division, University of Moratuwa, Katubedda, Moratuwa by mentioning the post applied on the top left hand corner of the envelope on or before the closing date of applications.

Applicants from the University System/Government Departments/Ministries/Corporations and Statutory Boards should channel their applications through the Head of their respective Institutions **using Form A and attaching a scanned copy of the same when submitting online. Applications submitted without Form A will not be entertained.**

Applications and all the relevant documents received after the closing date and incomplete applications and applications not submitted in prescribed format of the University of Moratuwa will be rejected without intimation.

(A) Senior Lecturer Grade I - [(Medical/Dental)]

- 1) Candidate who are applying for above post should possess academic qualifications required for Lecturer (Probationary)

AND

- 2) MD/MS with Board Certification of the Postgraduate Institute of Medicine (PGIM) or its equivalent

Or

A Doctoral Degree in the relevant field

Or

A Masters Degree in the relevant field with full time research of at least 24 months duration

Or

A Masters degree in the relevant field obtained through a Course of Study equivalent to 60 credits, as defined in SLQF Level 10 (or an equivalent parttime Course of Study), including a research component of at least 15 credits out of the 60 credits

AND

- 3) At least eleven (11) years experience of which not less than six (06) years should have been after obtaining qualifications stipulated in (2) above in one or more of the following:

- Teaching at University Level,
- Professional experience,
- Research in a recognized Institution,
- Postgraduate Studies

(B) Senior Lecturer Grade II - [(Medical/Dental)]

- 1) Candidate who are applying for above post should possess academic qualifications required for Lecturer (Probationary)

AND

- 2) MD/MS with Board Certification of the Postgraduate Institute of Medicine (PGIM) or its equivalent

Or

A Doctoral Degree in the relevant field

Or

A Masters Degree in the relevant field with full time research of at least 24 months duration

Or

A Masters degree in the relevant field obtained through a Course of Study equivalent to 60 credits, as defined in SLQF Level 10 (or an equivalent parttime Course of Study), including a research component of at least 15 credits out of the 60 credits

AND

3) At least six (06) years' experience in one or more of the following;

- I. Teaching at University Level,
- II. Professional experience,
- III. Research in a recognized Institution,
- IV. Postgraduate Studies to acquire the qualifications stipulated at (2) above.

(C) Lecturer (Unconfirmed) - [(Medical/Dental)]

1) Candidate who are applying for above post should possess academic qualifications required for Lecturer (Probationary).

And

* MD/MS & awaiting Board Certification of the postgraduate Institute of Medicine

Or

* A Doctoral Degree in the relevant field

Or

* A Masters Degree in the relevant field with full time research of at least 24 months duration

AND

2) Having Less than (06) years' experience in one or more of the following:

- i. Teaching at University Level,
- ii. Professional experience,
- iii. Research in a recognized Institution,
- iv. Postgraduate Studies to acquire the qualifications stipulated at (*) above.

(D) Lecturer (Probationary) - [(Medical/Dental)]

1) MBBS Degree with first class or second class (Upper Division) Honours

OR

2) MBBS Degree with Second Class (Lower Division) Honours

OR

3) MBBS Degree

And

A Doctoral Degree in the relevant field

Or

A Masters Degree in the relevant field with full time research of at least 24 months duration

OR

- 4) Such academic or professional qualifications or professional experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned

NOTES:

- I. Candidates who are eligible under category D (1) above will be interviewed and evaluated first.
- II. Candidates who are eligible under Category D (2) and D (3) above could be invited for an interview only if applicants qualified under category D (1) above are either not available or found to be unsuitable by the Selection Committee after interview and evaluation. Appointment of Candidates under Categories D (2) and D (3) would require the approval of the University Grants Commission.
- III. Candidates eligible under category D (4) above will be invited for an interview only if there are no suitable candidates under category D (1), D (2), D (3). Appointment of a candidate under category D (4) requires the approval of the University Grants Commission.
- IV. All candidates are required to make a presentation before the Selection Committee in order to prove their teaching ability as Lecturer (Probationary).

Salary and Academic Allowance will be paid according to the Commission Circular No. 02/2025 dated 01.04.2025.

In addition to the above salary, cost of living allowance and other approved allowances will be paid to the selected candidate/s.

CONDITIONS OF SERVICE:

01. These Posts are permanent. The appointment will be probation for a period of three (03) years.
02. Selected candidates, if presently serving in Government Departments will have to obtain their release through the Ministry of Public Administration. Government servants will not be entitled to maintain their pension rights whilst in the University Service.
03. Selected candidates, will become contributors to the Universities Provident Fund by means of monthly deductions from his/her salary an amount equal to ten (10%) percentum of his/her earnings. The University will, in addition out of its funds contribute at the same time a sum equal to seven (7%) percentum of his/her earnings to the Universities Provident Fund and eight (8%) percentum of his/her earnings to the Pension Fund.

04. Three percentum (3%) of the earnings will be contributed by the University to the Employees Trust Fund in terms of the Provisions of the Employees Trust Act No. 46 of 1980.
05. Other conditions of appointment will be in accordance with the provisions of the Universities Act No. 16 of 1978 and subsequent amendments and Ordinances, Regulations, Rules, etc., made thereunder.
06. Applicants from the University System/Government Departments/Corporations and Statutory Boards should apply through the Heads of their respective Institutions using form 'A' and attaching the scanned copy of the same. Application submitted without Form 'A' will not be entertained.

Special Note:

All Lecturers shall complete an Induction Training course (which includes Teaching/Learning Methodologies) within a period of one year from the date of first appointment. This is a pre-requisite for probationary study leave and confirmation in the post.
