A Bachelor's Degree in Engineering which is recognized by the University Grants Commission (UGC) of Sri Lanka, in the field of Electronics, Electrical, Mechanical, Civil, Materials, Chemical, Production, Information, Communication & Digital Technology or any other Degree relevant to the subject area of the post which is awarded by a University recognized by the University Grants Commission (UGC) of Sri Lanka
