The Sri Lanka Ports Authority is looking for qualified individuals for the following posts:-

1. DEPUTY CHIEF SECURITY MANAGER (SENIOR LEVEL MANAGEMENT 2)

a) Eligibility

Should possess a Degree from a recognized University.

Five (05) years in active service as a Colonel of the Sri Lanka Army/Captain of the Sri Lanka Navy/Group Captain of the Sri Lanka Air Force/Senior Superintendent of Police.

b) Remuneration

Applicants who are willing to apply for the above posts should be below 45 years of age (This age limit will not apply to those in Government Departments or State Corporations)
