



# VACANCIES

## Sri Lanka Anti-Doping Agency



Applications are invited from citizens of the Democratic Socialist Republic of Sri Lanka for the following posts that are vacant at the Sri Lanka Anti-Doping Agency.

### Director (Education and Testing) ( 01 - Vacancy)

(1) Job Description

Planning annual and quarterly Stimulant Tests for risk assessment separately for maintaining the discipline in each sport, planning educational programmes to impart the awareness required for sportsmen and women, handing over the documents when the prohibited stimulant test are found to be positive to the Results Management Division, monitoring, training the Stimulant Control Officers and Stimulant Control Assistants, monitoring the immunity of therapeutic use, lead the subordinate staff towards the objectives of the institution, correct implementation of the decisions taken by the Board of Directors, carryout the duties vested by the relevant Act and implementation of the senior management duties entrusted by the Director General.

(2) Qualifications and Experience

2.1 Recruitment of External Applicants for the Post of Director (Education and Testing)

Should have obtained a Bachelor's degree in Medicine, Sports Science and Management recognized by the University Grants Commission With

A Postgraduate degree (Masters) in the relevant field

(b) Experience

Should have obtained at least Thirteen (13) years experience in the relevant field in a "Managerial Position" in Government, Government Corporation, Board, Statutory institution or reputed private institution

2.2 Recruitment of Internal Applicants for the Post of Director (Education and Testing)

1. Should have fulfilled the abovementioned qualification for the external applicants

2. Should have completed a satisfactory service period of at least three (03) years in the relevant subject field in a Grade I post in Management Service Category (MM)

3. Should have passed the second efficiency bar examination

(3) Salary Scale

HM 1-1-2025 - (Rs. 140,640 - 15 x 4,100 - 202,140) (Salary will be paid as per Management Service Circular No. 01/2025. In addition to that government approved other allowances are included)

(4) Age:

Should be not below 35 years and not more than 55 years. Maximum age limit is not applicable to the internal applicants

(1) Job Description

Explaining and implementation of all rules and regulations relevant to the Act relevant to the establishment of this institution and all other rules and regulations, working with the international institutions that work regarding the prohibited substances, updating the regulations and information appropriately along with such institutions and following those terms within Sri Lanka, acting coordinately with the state institutions and private institutions in our country that work regarding the prohibited substances, implementation of duties entrusted by the Act for the establishment of this institution and the senior managerial duties entrusted by the Director General.

(2) Qualifications and Experience

(2) Qualifications and Experience

External Applicants

Driver

2.1.1 Educational Qualifications:

Should have passed in six (06) subjects with at least two credit passes in not more than two sittings at the General Certificate of Education (Ordinary Level) Examination

2.1.2 Proficiency

Should have obtained a Driving License for driving heavy vehicles issued by the Commissioner General of Motor Traffic (Expected proficiencies should clearly stated) and should have obtained at least three (03) years experience driving vehicles after obtaining the Driving License.

Internal Applicants

Driver

Should have obtained a Driving License for driving heavy vehicles issued by the Commissioner General of Motor Traffic and should have obtained at least three (03) years experience driving vehicles after obtaining the Driving License.

And

Should have completed satisfactory service period of five (05) years in Primary Unskilled (PL 1) Service Category.

(3) Salary Scale:

PL 3 - 2025 - (Rs. 43,280 - 10 x 490 - 10 x 540 - 10 x 50 - 12 x 630 - 67,040)

(4) Age:

Should be not less than 18 years and not more than 45 years. Maximum age limit is not applicable to the internal applicants.

(5) Method of Recruitment

After calling for applications through a public notice or newspaper advertisement in national newspapers, recruitment to Grade III after selection based on the results of a structured interview conducted by a Board of Interviewers appointed by the Competent Authority for Appointments and by a trade test.

(6) General Conditions for the above posts

- Employees Provident Fund and Employees Trust Fund  
(Candidates should contribute 8% and the institution will contribute 12% to the Employees Provident Fund and the institution will contribute 3% for the Employees Trust Fund.)
- Only the shortlisted applicants based on the educational, professional qualifications and experience will be called for the interview.

(7) Others

Every applicant

- Should be a citizen of Sri Lanka
- Should be physically and mentally fit to discharge the duties entrusted to the post and to serve in any part of the island.
- Should bear an excellent moral character

(8) Method of Applying

- Applications that are not compatible and incomplete and late applications will be rejected.
- Any form of canvassing will be a disqualification.
