



# UNIVERSITY OF KELANIYA

## VACANCIES

The University of Kelaniya will entertain applications from suitably qualified persons for the following posts up to **22<sup>nd</sup> June 2026**.

### **01. Post : Management Assistant (Contract)**

A monthly salary of **Rs. 64,213/-** inclusive of the basic salary and cost of living allowance will be paid. Overtime allowances are applicable as per University rules and circulars.

Entitled to contributions to the University Provident Fund (UPF) and the Employees' Trust Fund (ETF).

**Age Limit :** Age should be not less than 18 years and not more than 30 years of age at the closing date of applications.

### **02. Post : Labourer (Contract)**

A monthly salary of **Rs. 58,563/-** inclusive of the basic salary and cost of living allowance will be paid. Overtime allowances are applicable as per University rules and circulars.

Entitled to contributions to the University Provident Fund (UPF) and the Employees' Trust Fund (ETF).

**Age Limit :** Age should be not less than 18 years and not more than 45 years of age at the closing date of applications.

### **Note :**

- Preference will be given to people who have experience working in a garden / field / work sites as a Labourer.
- People appointed shall work under Curator and University Garden.

### **Persons disqualified from Appointment to any post in the Commission/ Higher Educational Institutions/Institutes**

#### **A Person:**

- (a) who has been compulsorily retired for general inefficiency or retired as a merciful alternative to dismissal or whose services has been terminated or dismissed for disciplinary reasons after a formal inquiry;
- (b) who has vacated post while in the State Service or in the service of a Public Corporation or Statutory Board or in the service of the Commission or any Higher Educational Institution/ Institute;
- (c) who has been convicted by a Court of Law for a criminal offence committed against the Democratic Socialist Republic of Sri Lanka;
- (d) who has been convicted by a Court of Law in any Criminal proceedings or convicted by a Court of Law, after summary inquiry in terms of Section 449 of the Criminal Procedure Code;
- (e) who had been declared as bankrupt, should not be appointed to any post in the Commission or in any Higher Educational Institution / Institute. However, under exceptional circumstances those who are in categories (a) and (b) above may be considered for appointment with prior approval of the Commission.

Persons who are not citizens of Sri Lanka should not be appointed to any post in the Commission/ Higher Educational Institutions/ Institutes.

The University reserves the right to shortlist the candidates and / or not to recruit all the above positions or any of them due to a reason satisfied by Council. The decision of the Council would be the final in this regard.

Applications which do not meet the required qualifications, relevant qualification certificates not attached, incomplete, illegible and received after the closing date will be rejected.
