- III. Responsible for overseeing overall accounting functions, financial data and implementing cost-effective financial strategies
- IV. Budgeting, statutory account preparations, taxation matters, project costing & inventory management
- V. To liaise with the Chief Accountant of the line ministry & the General Treasury on financial matters
- VI. To liaise with the Auditor General / Banks / Suppliers/ Customers
- VII. Accurate & timely preparation and submission of Financial Statements and other financial and Management reports as required
- VIII. Supervision of function of accounting staff and their performance
- IX. Any other works assigned by the Chairman/ Director General and/or Director from time to time

1. Having obtained the qualifications required by the external candidates above
2. Completion of minimum five (05) years satisfactory service in a post in the in the Junior Manager (JM) Category, in the subject area relevant to the post.
