01. Assistant Registrar

Qualifications:

(a). External:

- (i) A Degree with First or Second Class of a recognized University / Higher Educational Institute.

OR

- (ii) A degree of a recognized University with a Postgraduate Degree / Postgraduate Diploma in Administration or Management of a recognized University/Higher Educational Institute.

(b). Internal:

- (i) A graduate of a recognized University/Higher Educational Institution who is a confirmed employee of the University.

OR

Employee who has completed a minimum of five (5) years of satisfactory service in the relevant field in a Grade II of the Management Assistant non technological (U-MN-I) or technological (U-MT-I) category.

Nature of Appointment:

- Permanent with entitlement to Employees 'Provident Fund and Employees' Trust Fund

Age Limit:

- Age should be not less than 22 years and not more than 45 years. The upper age limit will not apply to internal candidates.

Salary Scales:

- Salaries will be paid as per the Provisions of Management Services Circular No. 06/2025 dated 02/04/2025.

Salary Code:

- U-EX 1-2025

Selection Procedure:

- By a Written Competitive Examination and/ or Structured Interview.

Every applicant,

- i. Should be a citizen of Sri Lanka.
- ii. Should be physically and mentally fit to discharge the duties of the post well.
- iii. Should be of excellent moral character.

General Instructions:

- This post is non-transferable.
- The post applied for should be marked on the top left hand corner of the envelope.
- A letter from the employer indicating whether the applicant could be released in the event of his/her appointment to the post in case of an applicant serving in a government Institution.
- The duly completed applications on prescribed forms (downloaded from the University Website) together with the evidence of the relevant experience, educational qualifications and other achievements.
