Applications are invited from persons having the following qualifications for the recruitment on contract basis to the Posts of Flying Squad Officer existing vacant at the Flying Squad Division at the Head Office of the Sri Lanka Transport Board. This post is a one that requires to check the duties of work personnel who are on duty on the bus routes. (Those who have Legally left the Three Armed Forces will be given a special consideration.

01. POST OF FLYING SQUAD OFFICER (Contract)

Educational and Other Qualifications

- I) Passed G.C.E. (OL Level) Examination in 06 subjects in one sitting with Four (04) credit passes including Sinhala / Tamil and Maths.
- II) Passed G.C.E. (AL Level) Examination in at least three subjects (03) (except the Common General Paper).
- III) Followed a Computer Course of not less than Six months (06) duration recognized by the Tertiary and Vocational Education Commission.
- IV) Age should be between 18-45 years
- V) In perfect health and be a Sri Lankan citizen.
- VI) Physically and mentally fit so as to carry out duties entrusted perfectly as well as serve in any part of the island.
- VII) If the applicant happens to be from the Three Armed Forces, served in the permanent service or volunteer service, he should have left the service legally with a clear name.

General Conditions and Facilities Provided

- The employee should contribute 08 % of his salary towards the Employees Provident Fund and the employer will provide 12 % to the Fund. The employer will provide a further 3 % to the Employees' Trust Fund.
- **Monthly basic contract stipend.**
While the basic contract stipend paid will be Rs. 46,226 with cost of living allowance Rs. 17,800/- and overtime allowance, travelling allowance and other allowances that are paid to the Flying Squad Officers by the SLTB will also be entitled. They will be deployed on work rotation basis, once recruited.
- Applicants will be recruited as per the Board Procedures after an interview and thereafter referred to a Medical Test and those passing it will face a Training Course before recruitment.
- After appointment is made, a traveling pass will be given to travel to and from the service station within a 30 km radius.
- The Board of Directors of the SLTB retains the right to the final decision relevant to the above recruitment.

Interested applicants should self prepare their applications as per the specimen stated below and should send same addressed to "Chief Executive Officer, Sri Lanka Transport Board, No. 200, Kirula Road, Narahenpita, Colombo 05" to receive on or before 30.09.2026. The cover containing the application should be marked with the post applied for at the left side top corner. The school leaving certificate (student work performance and the Certificate of Legally leaving the permanent service in the Three Forces) should compulsorily be submitted. Applications that are submitted contrary to the specimen application and incomplete applications will be rejected.
