<u>Guidelines to Law Graduates from Recognized State/Foreign Universities and Barristers</u> <u>for Admission to Sri Lanka Law College - 2023 (1st Intake)</u>

1. Application for admission

Please send the duly filled Application Form to the email address <u>applications.admissions@sllc.ac.lk</u>on or before <u>January 27, 2023.</u>

You will be notified of the receipt of your application form and further steps to be taken by email. If you have not received the acknowledgment email on or before January 27, 2023, please contact the Student Registration Unit immediately.

2. <u>Required minimum qualifications</u>

- (i) He/She should be a citizen of Sri Lanka;
- (ii) He/She should have completed the seventeenth year of age at the time of making the application;
- (iii) He/She should submit a certificate of good character acceptable to the Council;
- (iv) He/She should be an LL.B. degree holder from a university recognized by the Incorporated council of Legal education (ICLE) on or before 30 December 2020 or later (only the universities that were approved temporarily between January 01, 2021 and December 31, 2022);
- (v) He/She should possess a minimum of a Credit pass in the English Language and a Credit pass in the Sinhala or Tamil Language, obtained at the Sri Lanka General Certificate of Education (Ordinary Level) Examination or National Certificate of General Education Examination or an Examination recognized by the Department of Examinations of Sri Lanka as an equivalent qualification to the above examinations;

3. <u>Required certificates/ documents</u>

- (i) Original LL.B. Degree certificate and/or detailed results sheet/s with a true copy;
- (ii) A letter from the relevant University/Society (the qualification awarding body) by confirming the candidate's commencement date of the degree program and the degree awarded date, address to the Principal, Sri Lanka Law College, No. 244, Hulftsdorp Street, Colombo 12.
- (iii) Original G.C.E. (O/L) Examination Certificate/s in proof of minimum Credit passes in English and Sinhala/Tamil languages, provided by the Department of Examinations/ the qualification awarding body with two (2) true copies

- (iv) A Character Certificate, addressed to the Principal, Sri Lanka Law College, No. 244, Hulftsdorp Street, Colombo – 12. (The certificate of good character should have been obtained within a period of six months of the application for admission and should, in the case of applicants who have passed out of universities, be from the Dean of the Faculty and if no educational institution has been attended immediately before application, from a Commissioner for Oaths (e.g., Justice of the Peace/Attorney-at-Law).
- (v) Original Birth Certificate (please note that if the original Birth Certificate is not in English Language, an English translation must be submitted).
- (vi) Three (3) colour photographs [Passport size (3.5 cm. x 4.5 cm.) one of which must be pasted and certified on page number four (4) of the application. The attestation is to be done by the Commissioner for Oaths (e.g., Justice of the Peace/Attorney-at-Law).
- (vii) One (1) certified true copy of the National Identity Card/Valid Driving License/Passport

4. Important

- (i) A Commissioner for Oaths (e.g., Justice of the Peace/Attorney-at-Law) must certify as a true copy of the required photocopies.
- (ii) In the event of any discrepancy between names in the certificates and birth certificate, the applicant is required to submit an affidavit along with the application form (you must give detailed information on why your name/s are different in those documents).
- (iii) applicant's name will be registered as a student according to the name appearing on their birth certificate.
- (iv) All inquiries relating applications for admissions 2023 (1st Intake) should be forwarded to registrations@sllc.ac.lk

5. (i) Fees payable (nonrefundable):
