1. Eligible applicants can drop their applications as per the given guidelines in the box kept at the Student Registration Unit on or before 19<sup>th</sup> June 2026.
2. The application and guidelines can be downloaded from the Sri Lanka Law College website ([www.sllc.ac.lk/notices](http://www.sllc.ac.lk/notices)).
3. Graduates who commenced Law Degrees at foreign universities on or after 30<sup>th</sup> December 2020 are not required to apply for this intake. They must sit for the Special Entrance Examination.
4. Applicants must ensure that they use the latest application and guidelines (version No. 2026 - 4) for this intake.

Guidelines to LL.B Graduates from State/Foreign Universities and Barristers for Admission to Sri Law College 2026 (2<sup>nd</sup> Intake)

**1. Application for admission**

- (i) Eligible applicants can drop their duly filled original application with clear handwriting as per the specimen with the required original/certified documents in the box kept at the Student Registration Unit on or before 19<sup>th</sup> June 2026.
- (ii) If eligible applicants are unable to come to the Sri Lanka Law College physically, they may send an authorized person to drop the said application **or** can send via Registered Post to reach "The Unit Head, Student Registration Unit, Sri Lanka Law College, 244, Hulftsdorp Street, Colombo 12" on or before 19<sup>th</sup> June 2026.
- (iii) "Application for Student Admission 2026 – 2<sup>nd</sup> Intake & Name of University" should be indicated on the top left corner of the envelope (please use A4/Legal size envelope).
- (iv) Applicants who have applied successfully will receive a confirmation email to their email within Ten working days with the application reference number. If any applicant does not receive such a reference number within Ten working days, contact the Student Registration Unit immediately with the supporting documents. The college will not consider any late appeals.
- (v) Successful applicants will be notified later of the date on which they are to present themselves with the original documents at Sri Lanka Law College for admission.
- (vi) Applicants **are not required** to pay an application fee at the time of applying. However, applicants should pay the course fee upon being informed of the date of their in-person interview.

**2. Required minimum qualifications**

- (i) He/She should be a citizen of Sri Lanka;
- (ii) He/She should have completed the seventeenth year of age at the time of making the application;
- (iii) He/She should submit a certificate of good character acceptable to the Incorporated Council of Legal Education (ICLE);
- (iv) The applicant should be eligible for admission to the college as per Gazette notification no. 2332/02 dated May 15, 2023.
- (v) He/She should possess a minimum of a Credit pass in the English Language and a Credit pass in the Sinhala or Tamil Language, obtained at the Sri Lanka General Certificate of Education (Ordinary Level) Examination **or** National Certificate of General Education Examination **or** an Examination recognized by the Department of Examinations of Sri Lanka as equal to the above examinations **or** any other qualification/s recognized by the Incorporated Council of Legal Education;
- (vi) He/She should possess a minimum of a Two Credit Passes and One Simple Pass in three subjects (except General English and General Knowledge subjects) at one and the same sitting at the G.C.E. (A/L) or International G.C.S.E. Examination or an Examination recognized by the Department of Examinations of Sri Lanka as equal to the above examinations **or** any other qualification/s recognized by the ICLE.

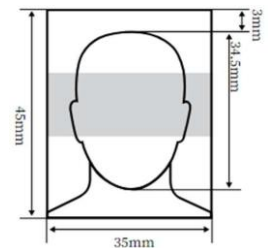
#### Special Note:

- (i) Applicants are required to submit the complete applications with the relevant attachments by the deadline of 19<sup>th</sup> June 2026, as outlined above. If not, the application will be rejected without prior notification.

If a foreign graduate is unable to obtain the original degree/transcript by 19<sup>th</sup> June 2026, they are required to request the issuing university (not from the local teaching institution) to directly transmit the transcript/degree confirmation to the designated email address: [registrations@slc.ac.lk](mailto:registrations@slc.ac.lk). Any late submissions will not be entertained.

Furthermore, such email confirmation will only be considered for the acceptance of the application. The originals should be submitted at the point of physical interview/document verification. If not, the candidate will not be considered for the 2026 – 2<sup>nd</sup> Intake.

- (ii) The degree confirmation letter must be addressed to the Principal, Sri Lanka Law College, No. 244, Hulftsdorp Street, Colombo 12.
- (iii) The Original certificates/documents (G.C.E. or I.G.S.C.E. (O/L and A/L), degree/transcript certificates) must be obtained from the Department of Examinations/ the qualification awarding body. Illegible certificates/documents issued by schools or teaching institutes or any other unauthorized institutes will be rejected.
- (iv) A Certificate of good Character should have been obtained within Six months of the application for admission, from a **Commissioner for Oaths/Justice of the Peace (All Island)**, addressed to the Principal, Sri Lanka Law College, No. 244, Hulftsdorp Street, Colombo 12.
- (v) The Grama Niladhari Certificate (DS 04 form) should have been obtained within Six months of the application for admission. The Certificate must mention the purpose for which the certificate is required as "Admission to Sri Lanka Law College". Furthermore, the applicant's character should be mentioned in item number (3) (e). Furthermore, the address in the DS 04 form and Application form should be the same. If any deviations are found, the DS 04 form's address will be considered the applicant's permanent address.
- (vi) The Three (3) coloured photographs (bust only) must be in Passport size (3.5 cm. x 4.5 cm.) and
  - a) One of which must be pasted on page number Six (6) of the Application.
  - b) The attestation is to be done by the Commissioner for Oaths on page number Six (6) of the Application.
  - c) All three photographs should be the same and;
  - d) The photo must be in size 35x45 mm (3.5x4.5 cm).
  - e) The photo must be a Color Photograph taken in the last 3 months.
  - f) The background must be True Blue Color (RGB Valus: 0, 120, 215).
  - g) The photo to be a high-resolution photo that is not blurry, and grainy, or pixelated and;
  - h) Have a neutral facial expression or a natural smile, with both eyes open.
  - i) Face the camera directly with full face in view (No selfies).
  - j) The clothing must be Formal Wear.



#### 4. Important

- (i) The applicant should request the University (the LL.B. qualification awarding body) to confirm his/her qualifications including the awarded qualification, commencement date, and completion date via email to Sri Lanka Law College at [registrations@sllc.ac.lk](mailto:registrations@sllc.ac.lk) on or before the in-person interview.
- (ii) A Commissioner for Oaths/Attorney-at-Law/Justice of the Peace (All Island) **must** certify as a true copy the required photocopies of certificates.
- (iii) In the event of any discrepancy between names in the certificates and Birth Certificate, the applicant is required to submit an Affidavit along with the application form (you must give detailed information on why your name/s are different in those documents).

Additionally, each certificate or document included in the Affidavit is required to specify at least three pieces of information. This may include details such as the date of issue, index number or candidate number, and the name of the person or institute issuing the document or certificate etc.

- (iv) The Applicant will be registered as per the name on their Birth Certificate.
- (v) A Sri Lanka Citizen, who resides overseas can send the application directly to the Law College through the Registered Post/Courier Service. (the attestation to be done at the Sri Lankan Consular Office/Embassy).
- (vi) Do not use stapler pins **or** any other tools which cause damage to scanner machines.
- (vii) Laminated or altered documents/certificates may not be considered for admission.
- (viii) **Enquiries** relating to calling applications for admission 2026 (2<sup>nd</sup> intake) should be forwarded to [registrations@slc.ac.lk](mailto:registrations@slc.ac.lk).

- (vii) Check your names and the spellings carefully, and in case of any discrepancy between names in the Application form and your Birth Certificate, you are required to submit an Affidavit.
- (viii) Ensure that you place your signature and date on all pages of the application form.
- (ix) Original certificates and true copies of the required documents must brought according to the table as given above.

**8. Applications will be rejected due to the following:**

- (ii) Illegible applications;
- (iii) Submitting more than one application by the same applicant.
- (iv) Applications which are incomplete and/or scanned.

- (vii) Applications that are not in hand written form (a candidate for admission Must fill out the application form in his/her handwriting).
- (viii) Late applications or applications from unqualified persons **or** applications which are sent by email **or** any other mode of submission.
- (ix) Applications of candidates who failed to obtain from their University (the qualification awarding body) confirmation of his/her qualifications including the awarded qualification, commencement date, and completion date, via email to Sri Lanka Law College at [registrations@slc.ac.lk](mailto:registrations@slc.ac.lk) on or before the in-person interview.
