1. General Qualifications required :

1:1 Every applicant must furnish satisfactory proof that he is a Sri Lankan. A Sri Lankan, is a citizen of Sri Lanka by descent or by registration as defined in the Sri Lanka Citizenship Act.

1:2 A candidate for any post for which the minimum educational qualification prescribed is a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass either in Sinhala language or Tamil language obtained, as the case may be, at the Senior School Certificate Examination or its equivalent if he is either a Sinhalese educated in Sinhala Medium or if he is a Tamil educated in Tamil Medium (This requirement will not apply to those who are in the public service from a date prior to January 01, 1961, and who seek appointments to other posts in the public service).

1:3 Application from the New Entrants, Public Officers, who are not either Sinhala or Tamil educated, whose probationary trial appointments have been terminated for failure to pass the prescribed official language proficiency tests will not be entertained unless they have obtained the qualifications which could entitle them to seek exemptions from the highest proficiency test prescribed for the post.

2. Conditions of Service-General :

2:1 All officers in the Public Service will be subject to the Financial Regulations, the Establishments Code, Departmental Orders or Regulations and any other Orders or Regulations that may be issued by the Governments from time to time.

2:2 A Public officer may be required to furnish security in terms of the Public Officers (Security) Ordinance, in such sum and in such manner as the secretary to the Ministry concerned may determine.

2:3 A Public Officer may be called upon to serve in any part of the Island.

3. Conditions of Service applicable to Public Officers holding permanent appointments :

3:1 In addition to the conditions referred to in Section 2 above Public Officer holding permanent appointments will be subject to the following further conditions:

3:1:1 All appointments will be on probation for a period of 3 years unless a longer period is considered necessary in respect of any post. Any appointment may be terminated at any time during the period of probation without a reason being assigned.

3:1:2 All public officers are required to conform to the provisions of the Chapter IV of the Constitution of the Democratic Socialist Republic of Sri Lanka and any other laws, regulations or rules that may be made from time to time to give effect to the Language Policy of the Government.

3:1:3 All Public officers who have not entered the Public Service either in Sinhala Medium or in Tamil Medium are required to acquire a working knowledge in one of the official languages.

3:1:4 Confirmation at the expiry of the period of probation of an officer who entered the Public Service in a medium other than Sinhala or Tamil will depend, inter alia, on the passing of the Grade I Proficiency Test in one of the Official Languages within one year; Grade II Proficiency Test within two years, and Grade III Proficiency Test (where applicable) within three years from the date of appointment.

Failure to pass a test within the prescribed period will result in the suspension of increments. Suspension will be converted to a stoppage if the test is not passed within a further period of six months beyond the prescribed period such stoppage operating until the test is passed or until such time as the provisions of Section 3:1:6 below apply.

3:1:5 Such officers should, on receiving appointment, be given facilities on full pay, for a period of 6 months to obtain proficiency in one of the official languages. He will thereafter, be required to sit the relevant proficiency examination and if he does not pass he will be given the opportunity to pass the examination within a period of 2 years immediately after the period of 6 months on full pay, while he performs his normal duties.

3:1:6 If he fails to pass the examination in this prescribed period of 2 1/2 years his services will be terminated.

3:1:7 A Public Officer already confirmed in permanent post in the Public Service will not normally be required to serve the period of probation on being appointed to another permanent post in the Public Service. Such Officers may in the first instance be appointed to act in the new post for a

specified period with a view to testing him in his new post.

3:1:8 Selected candidates (Other than those already holding permanent or temporary appointments in the Public Service) who have already been medically examined will be required to undergo a medical examination by a Government Medical Officer to test their physical fitness to serve in any part of the Island.

4. Terms of Engagement :

4:1 Public officers appointed to permanent and pensionable posts should contribute to the 'Widows and Orphans' Pension Scheme from their salary an amount equivalent to the percentage the Government requires to recover from their salary.

4:2 Public officers appointed to permanent or temporary posts on Provident Fund basis will be required to contribute 6% of their consolidated salary to the Public Service Provident Fund. The Government will contribute as its share of contributions an amount equal to 150% of the compulsory contributions credited to the fund at the close of the Financial Year.

4:3 Officers who hold pensionable appointments in the Public Service and who are released for appointments to pensionable posts in the Local Government Service and those officers in the Local Government Service who hold pensionable appointments and who are released for appointments to pensionable posts in the Public Service will be allowed pensionability in their posts in the Local Government Service and Public Service respectively.

4:4 Regular Force personnel in the Army, Navy and Air Force who are released for appointments to posts in the Public Service which are pensionable under the Minutes on Pension will be allowed pensionability in their posts in the Public Service. Notwithstanding anything to the contrary in these Minutes the unforfeited full pay service of any member of the Armed Forces who is released to accept an appointment as a Public Officer in a post which has been declared to be pensionable under these Minutes shall be reckoned for the purpose of any pension or gratuity payable under these Minutes.

5. Serving Officers in the Public Service :

5:1 Applications from officers of the Public Service who possess all the necessary qualifications must be forwarded through the Heads of their respective Departments. In the case of applications from Public Officers holding post in the permanent establishment in the Public Service. Heads of Departments in forwarding such applications should state whether the applicants could be released or not to take up the new appointment, if selected.

5:2 Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.

5:3 Anyone desiring to recommend a candidate should do so by giving a testimonial. Any form of canvassing or any attempt to influence the selection of a candidate will disqualify such candidates.

5:4 Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection and to dismissal if discovered after the selection.

5:5 Application not conforming in every respect with the requirements of the advertisement will be rejected.

6. Definition of Salary for the purpose of Eligibility :

6:1 Salary for purposes of eligibility means only the consolidated salary and does not include any action salary, allowances etc.

7. New National Policy on Recruitment and Promotions :

Recruitment and Promotion in the Public Service, Provincial Public Service, Public Corporate Sector and Companies fully owned by the Government will be done in accordance with the policy laid down in the Public Administration Circulars No. 15/90 of 09.03.1990, 15/90 (I) of 25.03.1990 & 15/90 (ii) of 15.06.1990 with effect from 01.01.1990 subject to amendments that will be done by subsequent Public Administration Circulars.

RULES AND INSTRUCTIONS FOR EXAMINATION CANDIDATES

All examination candidates are bound to act in compliance with the provisions of the Public Examinations Act, No 25 of 1968 which was amended by No 19 of 1976 and other rules and regulations imposed from time to time.

The following conditions and restrictions are hereby imposed through the Sentence No. 20 of the Public Examinations Act, No 25 of 1968 which was amended through No 19 of 1976 as per the powers assigned to the Commissioner General Examinations

All examination candidates are bound to abide by the rules given below and a candidate who violates any of these rules is liable to one or more of the following penalties mentioned below at the discretion of the Commissioner General of Examinations

- I. Debarring to appear for the whole examination or part of it which was under investigation.
- II. Disqualifying from one subject or from the whole examination which was under investigation.
- III. Imposing lifetime ban for all the examinations conducted by the Department of Examinations, Sri Lanka.
- IV. Debarment from appearing for examinations conducted by the Department of Examinations, Sri Lanka for a certain period of time.
- V. Issuing a letter with suspended debarment of examination.
- VI. Suspension of the certificate for a specific period
- VII. Handing over the examination candidate to the police to file a criminal case under the Public Examinations Act or complaining the police regarding such act.
- VIII. When the examination candidate is a government employee, reporting the appointing authority of such examination candidate (to take disciplinary actions) regarding the conduct of such examination candidate.

The Commissioner General of Examinations reserves himself the right to take actions with respect to such examination candidate prior to, during or after the examination or at any stage. His decision with respect to that should be deemed final.

1. Every examination candidate should act in the examination hall and at the examination premises in such a manner that any disturbance or obstruction should not take place for the examination supervisor and his staff as well as for other examination candidates. Moreover, examination candidates should not vandalize the property of the examination premises or damage the private property of the examination staff.

2. Examination candidates should act in compliance with the instructions given by the examination supervisor and his staff when the examination is in progress and before the commencement of the examination as well as immediately after the end of the examination.

3. No examination candidate will be admitted to the examination hall after the lapse of half an hour subsequent to the commencement of the question paper at an examination. Also, no examination candidate will be permitted to leave the examination hall until the examination ends. Actions should be taken to participate for practical tests or oral tests on time.

4. Every examination candidate should sit on the seat reserved for him/her bearing the respective Index Number and not any other seat. Unless with the special permission of the examination supervisor, no candidate should change his/her seat. The occupation of a seat other than the one assigned to him/her is liable to be considered as an act committed with dishonest intention.

5. Absolute silence should be maintained in the examination hall. A candidate is forbidden to speak to or to exchange messages or to have any dealing with any person within or outside the examination hall for any matter other than a member of the examination hall staff.

6. Since the answer script of an examination candidate will be solely identified through the candidate's Index Number, it is completely prohibited to write one's name on the answer script, put a certain mark or note to distinguish the answer script, write indecent or unnecessary things on the answer script and attaching currency notes with the answer script. Further, writing other examination candidate's Index Number on one's answer script could be considered as an attempt to commit a dishonest act. Answer scripts bearing Index Numbers those are difficult to decipher are liable to be rejected.

7. Examination candidates should not write on question paper or desk or any other place except on the papers (papers given to answer with the invigilator's short signature and the date with regard to the day on which the examination is conducted) supplied at the examination hall. Acting non-compliance with these instructions will be considered as an act committed with dishonest intention.

8. Any paper or answer books supplied to examination candidates should not be torn up or crushed. Each and every sheet of paper used for rough work should be clearly crossed out and attached to the answer script or submitted with the answer script at the end of the examination or the candidate should do the needful as per the given instructions. It is forbidden to take out anything written inside the examination hall. If a question has been answered twice in two different places, the unnecessary answer should be clearly crossed out.

9. It is forbidden to take out the papers or any other material supplied to answer at the examination out of the examination hall. All such materials are belonged to the Commissioner General of Examinations and breach of this rule will be considered as a punishable act.

10. When examination candidates appear for the examination in the examination hall, they should not keep in their possession or by their side other note books, papers with notes or paper pieces except the stationery supplied to them for answering at the examination and the materials which were authorized in written for each examination. Also, keeping mobile phones, electronic communication instruments/ devices in one's possession or by one's side and obtaining assistance from external parties through such instruments/devices and sending information to other parties and social media while the examination is in progress are considered to be dishonest acts and punishable offences.

11. In case electronic communication instruments/devices are revealed to be used for the purposes mentioned in the above paragraph no. 10, such instruments/devices will be taken into the custody of the Commissioner General of Examinations until the investigations are concluded.

12. After sitting in the examination hall, an examination candidate is strictly forbidden to keep any unauthorized material or instrument in his/her possession prior to the examination or when the examination is in progress. In case the supervisor or the examination staff orders, each candidate is bound to declare everything he/she has with him/her and get them

checked. Breach of these requirements should be considered as an attempt to commit an act of dishonesty.

13. It is an offence, in case a candidate copies or attempts to copy from the answer script of another candidate or a book or a script or a paper containing notes or through signals or any other source or acts dishonestly. Also, helping another candidate and getting help from another candidate or a person or exam staff are also offences and every completed answer sheet should be kept underneath the sheet on which the answer is being written. Writing papers should not be strewn all over the desk.

14. A candidate will under no circumstance whatsoever be allowed to leave the examination hall even for a brief period during the course of the paper after the commencement of the examination. However, in case an examination candidate needs to leave the examination hall to use the lavatory/ urinal, the candidate will be permitted to go outside for a brief period under the surveillance of an officer belongs to the assistant staff of the examination supervisor. He/ She shall be subject to search before leaving the examination hall as well as when re-entering it.

15. Impersonation before commencement of answering at the examination hall or after, is a punishable act. Tampering with identity cards or presenting false identity cards is considered to be an act of dishonesty.

16. Assistance given to a candidate in an improper and dishonest manner by a candidate or a person, who is not a candidate, is considered to be a serious offence.

17. Examination candidate should adhere to the following instructions

- I. Every examination candidate should take actions to get the signature in their admission paper attested and get the subjects amended prior to the examination, after inquiring the Department of Examinations, Sri Lanka in case there is any discrepancy between the subjects applied and the subject indicated in the admission paper.
- II. It is appropriate to arrive the examination hall, half an hour prior to the commencement of the examination and if you are not quite certain of the location of the examination hall, make inquiries on a day prior to the date of examination and be sure of its exact location.
- III. Candidate should produce their identity cards and get their identities confirmed at every paper they sit when appearing for the examination.
 - (a) Actions will be taken to cancel the candidature in case a candidate fails to produce the identification documents at the examination hall and in case a candidate forgets to bring such documents into the examination hall, that fact should be brought to the notice of the supervisor and arrangements should be made to produce them before the examination ends.
 - (b) Every candidate should be in the examination hall during the examination period in such a way that his/her face should be clearly recognizable to display his / her identity in a clearly visible manner.
- IV. Examination candidates should keep their ears openly and in a clearly visible manner so as to confirm that they are not using electronic communication instruments/ devices like Bluetooth.
- V. No paper other than those issued at the examination hall should be used for answering questions. Excess paper and other materials should be left on your desk in good condition in a reusable manner.
- VI. Examination candidates should bring their own pens, pencils, erasers, foot rulers, geometrical instruments, boxes of coloured pencils and boxes of coloured chalks, etc.
- VII. When you start answering, you should promptly write down the Index Number clearly on the answer book used and each sheet of paper. Write answers clearly and legibly on both sides of the paper. You should leave at least a single blank line after providing the answer to a part of a question before starting to answer the next part of such question. You should provide answers in a fresh page for each question.
- VIII. The left-hand margin of the answer sheet is set apart to enter the question number. Since the right-hand margin is reserved for the examiner's use, nothing should be written there. Actions should be taken to number the questions you answered correctly as incorrect numbering leads to confusion.
- IX. When mathematical questions are answered, give all details of calculations and any rough work in their serial order as part of the solving of the sum. The sketches and diagrams drawn in the relevant places should be accurate and sufficiently large.
- X. You should read carefully the instructions given at the head of the questions paper with regard to the compulsory questions and the other questions which should be selected. Marks will not be granted for answers provided disregarding the given instructions in the question paper.
- XI. At the end of answering for each question, in addition to the answer book used, the answer sheets should be collected according to the page number and then should be tied/ attached at the top left-hand corner in a non-detachable manner. Make sure whether you have attached all the answer sheets prior to handing over the answer script. Any answer sheet taken out of the examination centre will not be evaluated after the handing over of such answer scripts.
- XII. Your answer script should be handed over to the examination supervisor or to an officer of his/her staff. You should remain in your seat until the answer scripts are collected. Failure to do so may result in the loss of your answer script and your being treated as an absentee for a certain subject.
- XIII. If it becomes necessary for you to speak to the examination supervisor or an officer of his/her staff due to a certain matter, you should sign him by tapping two times on the desk without disturbing others.

01. Applicant should be a permanent resident of relevant Births, Deaths and Marriages/ Additional Marriages Division and entitled to reasonable properties and should be a person with outstanding personality who has acquired sufficient interest and influence amongst the residents of the area.
02. This position is an unpaid service and both Male and Female candidates can apply for this post.

N.B. In case a subject contains 02 parts at G.C.E. (O/L) or any other similar examination, it shall be considered as one subject and pass is applicable only if the applicant passes both parts of the said subject.
07. Applicant should have the ability to establish the office in a centrally located building that ensures respect of the post and easy access by all or majority of residents.

8.1 A background check will be conducted regarding the applicants who are expected to be recruited as per above 7.2 paragraph to make sure that have maintained a good character.

Note :- There should not be any criminal reports regarding the applicant's next of kin. Applicant's mother, father, guardians, siblings and if the siblings are married, their spouses are also considered as next of kin.

01. IT is hereby notified that the Efficiency Bar Examination for Authorized Officers of (Grade II) will be held in Colombo in the year 2026 by the Sri Lanka Institute of Development Administration in compliance with the provisions of the relevant Approved Scheme of Recruitment for the Authorized officers of the Department of Immigration and Emigration.
02. (i) The Candidates are subject to the rules and regulations stipulated by the Sri Lanka Institute of Development Administration regarding the holding of examination and the issuance of results. The decision of the Director General of Sri Lanka Institute of Development Administration will be the final decision on conducting the examination and the issuance of results.
- (ii) If the candidates violate the rules imposed by the Sri Lanka Institute of Development Administration, they will have to be subjected to a penalty imposed by the Director General of the Sri Lanka Institute of Development Administration.
03. Examination Fees.- Candidates may sit the subjects of the examination either in one sitting or separately. LIMITED COMPETITIVE EXAMINATION FOR RECRUITMENT TO THE POST OF METEOROLOGICAL OBSERVER / COMMUNICATOR (TRAINING GRADE) OF SRI LANKA TECHNOLOGICAL SERVICE - 2026

1.0 Applications are invited from qualified employees of the Department of Meteorology for the Limited Competitive Examination held to recruit for the Training Grade to fill the vacant posts of Meteorological Observer / Communicator of the Sri Lanka Technological Service existing in the Department of Meteorology. This examination will be conducted in Colombo in October 2026 by the Commissioner General of Examinations.

1.1 Designation: Meteorological Observer / Communicator

1.2 Nature of duties of the post

- Collection of meteorological data
- Maintenance of meteorological instruments
- Provision of meteorological data to external organizations
- Entering meteorological data into the website
- Monitoring and reporting of special meteorological data

2.0 Candidates who have qualified based on merit according to the results of the written examination conducted by the Commissioner General of Examinations will be recruited as Meteorological Observers/Communicators of the Sri Lanka Technological Service for a training period of 02 years. Officers who pass the proficiency test to be held at the end of the said training will be appointed to Grade III of the Meteorological Observer / Communicator position in the Sri Lanka Technological Service. This post is permanent and pensionable. It is subject to a probation period of 3 years.

i. This examination is conducted for recruitment to the post of Meteorological Observer / Communicator (Training) of the Sri Lanka Technological Service in the Department of Meteorology.

ii. Written Examination - This examination consists of the following 02 question papers.

- Question paper on basic knowledge of mathematics
- Question paper on basic knowledge related to the post

3.0 The number of candidates to be appointed and the effective date of the appointment will be determined

by the Appointing Authority. In the event that the number of candidates who obtain equal marks for the total number of vacancies or for a few vacancies exceeds the number of available vacancies, the filling of such vacancies will be decided in accordance with the orders of the Public Service Commission, pursuant to Section 92 of the Procedural Rules.

I. Out of the total number of vacancies, 19 vacancies will be selected from the applicants who qualify through the limited competitive examination, and only if there are no internal applicants with basic qualifications within the Department of Meteorology to be recruited through the limited competitive examination, the remaining vacancy balance will be filled by external applicants selected through the open competitive examination itself.

4.0 Salary will be paid as follows.

4.1 Officers admitted to the Training Grade under the limited stream shall continue to remain on the same salary scale they held prior to entering the Training Grade, and in addition to the salary, an annual allowance equivalent to the initial salary increment of Grade III of the Sri Lanka Technological Service will be paid from the commencement of the training course until they pass the final examination conducted by the Department applicable to the Training Grade.

4.2 An officer who satisfactorily completes the first year of the Training Grade will be placed on the next salary step of the same salary scale they have held so far during their second year, and the allowance specified in 4.1 will also be entitled for the second year.

4.3 According to Public Administration Circular No. 10/2025 dated 25.03.2025, the salary scale applicable to Grades III, II, and I of the Meteorological Observer / Communicator position of the Sri Lanka Technological Service is Rs. 52,250 - 10X800 - 11X1,190 - 10X1,320 - 10X1,350 - Rs. 100,040/- (MN 3 – 2025).

4.4 After satisfactorily completing the training and passing the examination, and upon appointment to Grade III of the Sri Lanka Technological Service, salary conversions will be carried out to place the officer on the relevant salary step in accordance with Public Administration Circular No. 10/2025 dated 25.03.2025. Accordingly, steps will be taken to place the officer on the applicable salary step and pay the salary.

5.0 General Terms and Conditions of Employment:-

- 5.1 The number of candidates to be appointed and the effective date of the appointment will be determined by the Appointing Authority. The Appointing Authority reserves the power to refrain from filling any number of vacancies or all of the vacancies.
- 5.2 A selected candidate shall complete a training period of 02 years subject to the general conditions governing appointments in the public service, the provisions of the Establishments Code, the provisions of the Financial Regulations, the Procedural Rules of the Public Service Commission published in the Extraordinary Gazette No. 2310/29 dated 14.12.2022, and the regulations enacted or to be enacted or amended hereafter in the Sri Lanka Technological Service Minute published in the Extraordinary Gazette No. 1930/12 dated 01.09.2015 of the Democratic Socialist Republic of Sri Lanka.
- 5.3 Selected candidates shall be required to serve in any part of the island.
- 5.4 The duty hours will not always be standard office hours and will include both day and night shifts, as well as Saturdays, Sundays, and public holidays. Duties must also be performed according to shift rosters.
- 5.5 Prior to the commencement of the training, an agreement must be entered into with the Department stating that the candidate will fully complete the two-year training and serve the Department for a period of 05 years following the completion of the said training, and a bond must be signed and executed with the attestation of two sureties acceptable to the Department, undertaking that in the event he/she leaves the training after its commencement date or fails to serve the Department for the agreed period, the cost incurred by the Government for the training along with a valid sum of Rs. 250,000/- shall be paid to the Democratic Socialist Republic of Sri Lanka.
- 5.6 An officer recruited through a language medium other than the official language shall pass the official language proficiency test during the probation period. Failure to pass this test within the stipulated period will result in the deferment of the next salary increment.
- 5.7 In accordance with Public Administration Circular No. 18/2020 and its subsequent

concurrent circulars, the prescribed official language proficiency must be acquired within 03 years from the date of permanent appointment; failure to acquire this proficiency will result in the deferment of salary increments until such proficiency is obtained

- 6.0 Qualifications :- The following qualifications are applicable for recruitment to the Meteorologist Observer / Communicator Training Grade of the Sri Lanka Technological Service.

6.1 Educational Qualifications

- (A) Passing the G.C.E. (Ordinary Level) Examination in not more than two sittings in six subjects, including credit passes for Language or Literature, Mathematics, and Science.

6.2. Experience

- (A) Having at least ten (10) years of active and satisfactory service experience in a permanent departmental post in the relevant field within the Primary Non-Skilled or a higher service category.

6.3 Physical and Mental Qualifications

- (A) Every candidate must possess adequate physical and mental fitness to serve in any part of Sri Lanka and to discharge the duties of the post.

6.4 Other

- I. The appointment must have been confirmed.
- II. Must have completed an active and satisfactory service period of at least five (05) years under a permanent, departmental post in the public service immediately preceding the prescribed date, and this must be certified by the Head of the Department.
- III. An officer shall be considered to have fulfilled the required qualifications to sit for the written recruitment examination only if all qualifications have been fully completed in every respect as of the closing date specified in the calling for applications notice.

7.0 Examination Procedure :-

- 7.1 This examination will be conducted only at examination centers established in the city of

Colombo, and it will be held in Sinhala, Tamil, and English mediums. A candidate must select the medium applicable to them, and must answer all the examination papers in that same medium. Permitting changes to the requested medium will not be allowed subsequently. The examination consists of two question papers.

7.2 Syllabus:-

I. Basic Mathematical Knowledge Question Paper :-

Algebra, Geometry, and Trigonometry of G.C.E. (Ordinary Level) standard

- I Section - 40 Multiple Choice Questions. (Marks 2.5 x 40 = 100)
- II Section - Consisting of a question paper requiring essay-type answers, where 05 out of 07 questions must be answered. (Marks 20 x 5 = 100)

II. Basic Knowledge Question Paper Relevant to the Post:-

This is a question paper requiring essay-type answers. Out of 07 questions provided, 05 questions must be answered. (Marks 20 x 5 = 100)

7.3 Examination Results :-

The final results list, prepared by including a number of candidates equal to the number of vacancies based on the priority of written exam marks of the candidates who passed the written exam and qualified for the general interview, will be provided by the Commissioner General of Examinations to the Director General of

Meteorology. Thereafter, upon receiving the concurrence of the Director General of Meteorology, the results of all candidates will be notified by the Commissioner General of Examinations either by publishing them on the Department of Examinations website (www.results.exams.gov.lk) or by post. The decision of the Commissioner General of Examinations regarding the examination results shall be final.

8.0 Selection Procedure :-

8.1 Based on the results of the written examination conducted by the Commissioner General of Examinations, a number of candidates equal to the number of expected vacancies will be recruited from among those who scored the highest marks, in order of merit.

8.2 An interview will be conducted to verify qualifications; however, no marks will be awarded for the interview.

9.0 Recruitment :-

9.1 Those selected for the training grade will be appointed to Class III of the Sri Lanka Technological Service (SLTS) upon passing the examination held at the end of the two-year training period. The post is permanent and pensionable, and is subject to a probation period of one year.

10.0 Action against Furnishing False Information :

If it is revealed that a candidate is disqualified from sitting for this examination, or if it is found that any information submitted is intentionally false or that an important fact has been willfully concealed, his or her candidature may be cancelled either during or after the examination, and if revealed after recruitment, he or she may be dismissed from service.

11.0 Submission of Applications :-

The examination fee is Rs. 600/-. When paying the examination fee, payments must be made exclusively through the payment methods provided by the online system.

- (i) Any Bank Credit Card,
- (ii) Any Bank Debit Card with the Facility of Internet Transactions,
- (iii) Online Banking Method/ Flex App of Bank of Ceylon,
- (iv) Any Branch of the Bank of Ceylon.

Note:-

- (A) Instructions on how to make payments using the above methods are published on the website under the technical instructions relevant to the examination.
- (B) Notification of payment receipt will be sent *via* SMS or email. The full amount for the examination fee must be paid, and applications with under payments or overpayments will be rejected. The Department of Examinations, Sri Lanka, shall not be held responsible for any errors occurring during the payment of examination fees through the aforementioned methods.
- (C) The fee paid for the examination will not be refunded or transferred to any other examination under any circumstances.

11.1 The application for this is published on the website of the Department of Examinations, Sri Lanka (www.doenets.lk) under "Our Services" *via* "Online Application – Recruitment Exams", and applications can be submitted through the online method only. The acceptance of online applications will open at 9:00 a.m. on July 13, 2026, and close at 9:00 p.m. on August 13, 2026.

- Officers must hand over a copy of the application to their heads of institutions to be included in their personal files, and a copy of the application certified by the head of the institution along with a service confirmation letter must be presented when called for the interview.
- Applicants must bear any adverse consequences arising from delaying the submission of applications until the closing date.

11.2 Since changing the language medium of appearance later will not be permitted, the application must be completed accurately.

11.3 Appointments will be issued to selected applicants strictly under the name with initials as stated in the application, and therefore, the name must be entered accurately.

11.4 The online examination application must be completed in the English language only.

11.5 The system will notify you *via* an SMS to the mobile phone number used to log in, or *via* email, as to whether the online submitted soft copy has been accepted or not accepted by the Department as a valid application. Download the instruction sheet prepared for exam applications

before completing the online application. Follow those instructions accurately when filling out the application. No amendment made after obtaining a printed copy of the application will be considered a valid amendment. Incomplete applications will be rejected without notice.

12.0 Examination Admission Cards:-

Admission cards will be issued online only by the Commissioner General of Examinations to applicants who have paid the prescribed examination fee and submitted accurately completed applications on or before the closing date, under the presumption that only those possessing the qualifications specified in the gazette notification have applied. As soon as the admission cards are issued, the Department of Examinations, Sri Lanka, will notify the applicants via a web notice or an SMS. If there is any candidate who has not received their admission card, they must inquire from the Institutional Examinations Organizing Branch of the Department of Examinations, Sri Lanka, as mentioned in the notice. When making such an inquiry, it will be most effective to send a request letter to the email address mentioned in the web notice, accurately stating the name of the examination applied for, the applicant's full name, National Identity Card (NIC) number, and address. In doing so, it will be useful to keep a photocopy of the completed application and a photocopy of the examination fee payment receipt to verify any information requested by the Department of Examinations. The admission card must be checked, and if there are any amendments, the Department of Examinations should be contacted well in advance to make the relevant corrections according to the application. Requests made for amendments at the examination hall or during the interview will not be considered.

13.0 Sitting for the Examination:-

13.1 This examination will be conducted by the Department of Examinations in October 2026 in Colombo, in the Sinhala, Tamil, and English mediums.

13.2 Examination candidates must have their signatures on the admission card certified prior to sitting for the examination. The admission card with the certified signature must be presented to the supervisor at the examination center, and you will not be permitted to sit for the examination without it. Furthermore, a candidate must sit for the examination only at the examination center assigned to him/her.

13.3 Examination candidates are subject to the rules and regulations imposed by the Commissioner General of Examinations regarding the conduct of the examination. If those rules and regulations are violated, the candidate shall be liable to any punishment imposed by the Commissioner General of Examinations.

15.0 If there is any matter not specified herein, it shall be decided by the Director General of Meteorology. All applicants shall be bound to comply with the general examination rules and regulations specified in this *Gazette*.

14.0 Identity of Candidates :-

01. APPLICATIONS are invited from qualified Sri Lankan citizens for the Open Competitive Examination conducted for recruitment to the vacant post of Telecommunication and Radar Technical Officer (Grade III) of the Sri Lanka Technological Service in the Department of Meteorology.

- i. Recruitment through this examination is done for the post of Telecommunication and Radar Technical Officer, Grade III of the Sri Lanka Technological Service in the Department of Meteorology.
- ii. *Written Examination* - This examination consists of the following 02 question papers.
 - i. Intelligence Test
 - ii. Subject-Specific Technical Question Paper.

02. Date of Examination and Conducting the Examination.:

This examination will be conducted in Colombo in October 2026 by the Commissioner General of

Examinations.

03. The total number of vacancies to be appointed is 04. In the event that the number of candidates who obtain equal marks for the final vacancy or vacancies exceeds the number of vacancies, the filling of such vacancies shall be decided in accordance with Section 92 of the Procedural Rules and as per the orders of the Public Service Commission. The effective date of appointment will be decided by the Director-General of Meteorology.

- i. Only if there are no internal applicants within the department with sufficient basic qualifications for the percentage to be recruited through the limited competitive examination, the remaining quota will be filled exclusively by external applicants selected through the open competitive examination.

04. Conditions of Service :

4.1. A candidate selected will be appointed to Grade III of the post subject to the general conditions governing appointments in the public service, the Establishments Code and Financial Regulations, the Procedural Rules of the Public Service Commission published in the Extraordinary *Gazette* No. 2310/29 dated 14.12.2022, the Minute of the Sri Lanka Technological Service

dated 01.09.2015, the terms and conditions of the Scheme of Recruitment belonging to the technical service posts of the Department of Meteorology, and any amendments made or to be made hereafter to the said scheme.

4.2. This appointment is permanent and pensionable. You shall be bound by any policy decision taken by the Government in the future regarding the pension scheme applicable to you. Further, you must contribute to the Widows' and Orphans' Pension Scheme / Widowers' and Orphans' Pension Scheme. You shall make contributions towards the same in such manner as may be prescribed by the Government from time to time.

06. Recruitment Qualifications :

- (A) (i) Should be a citizen of Sri Lanka.
(ii) Should be of excellent moral character.
(iii) Should possess adequate physical and mental fitness to serve in any part of the island.

(B) Educational Qualifications / Professional Qualifications / Experience

- i. Should have passed the G.C.E. (Ordinary Level) Examination in six (06) subjects at one and the same sitting, with credit passes for Sinhala/Tamil/English Language, Science, Mathematics, and one other subject.

And

- ii. Should have passed the G.C.E. (Advanced Level) Examination in 03 subjects at one and the same sitting.

The subject combination must be in one of the following formats.

(1) Physics, Pure Mathematics, and Applied Mathematics.

(2) With Physics

- (i) One of the subjects from Pure Mathematics / Applied Mathematics / Combined Mathematics;

Or

- (ii) One of the subjects from Chemistry / Agricultural Science / Information Technology / Computer Science;

Or

- (iii). Should have completed National Vocational Qualifications (NVQ) Level 6 credentials relevant to the job field;

Or

- (iv). National Diploma in Technology (NDT) awarded by the University of Moratuwa or the Hardy Advanced Technological Institute, Ampara;

Or

- (v). National Diploma in Engineering Sciences (NDES) awarded by the National Apprentice and Industrial Training Authority.

Or

- (vi). Higher National Diploma in Engineering (HNDE) awarded by the Ministry of Education and Higher Education;

Or

(vii). Diploma in Technology awarded by the Open University of Sri Lanka;

Or

(viii). Should have successfully completed Part I of the Engineering Examination conducted by the Institution of Engineers, Sri Lanka (IESL);

Or

(ix). Should have obtained other technical qualifications recognized by the Tertiary and Vocational Education Commission (TVEC) as equivalent in all respects to the aforementioned technical qualifications, following consultation with and obtaining observations from the Ministry of Higher Education and the institutions issuing the aforementioned technical certificates.

(C) Age :

The minimum age shall be 18 years and the maximum age shall be 30 years as at the closing date for applications. (Accordingly, only those whose birthdays fall on or before 13.08.2008 and on or after 13.08.1996 are eligible to apply for this.)

(D) Restrictions on Qualifications:

Acceptance of online applications will open at 9.00 a.m. on July 13, 2026, and will close at 9.00 p.m. on August 13, 2026.

8.2. Applicants who are currently employed in the Public Service or Provincial Public Service must hand over a copy of the application to their Head of Institution to be filed in their personal file, and must present a copy of the application certified by the Head of Institution along with a letter confirming their service at the time they are called for the interview.

8.3. The applicant must bear any adverse situation arising from delaying the submission of applications until the closing date.

8.4. The online examination application must be completed in English only. Whether the soft copy submitted online by the applicant has been accepted or rejected by the department as a valid application will be notified *via* a short message (SMS) to the mobile phone number used to access the system or to the email address. Before completing the online application, download the instruction sheet

8.5. As soon as the admission cards are issued, the Department of Examinations, Sri Lanka, will notify the applicants *via* a web notice/ short message (SMS). Any candidate who has not received their admission card should inquire from the Institutional Examinations Organizing Branch of the Department of Examinations, Sri Lanka, as specified in the notice. Any other applicant must have their signature attested by the Grama Niladhari of the division, a principal of a government school, a Justice of the Peace (JP), a Commissioner for Oaths, an Attorney-at-Law, a Notary Public, a Chief Incumbent or a Chief Prelate of a Buddhist temple, or an individual in charge of any other place of worship or holding a significant position among the clergy.

09. Admission to the Examination:

(A) A candidate must sit for the examination at the

examination hall assigned to him/her. Every candidate must have his/her signature attested on the examination admission card and hand it over to the Supervisor of the examination hall on the very first day he/she appears at that hall. The admission card with the attested signature must be presented, and no candidate shall be permitted to sit for the examination without such an admission card. A set of rules to be followed by every candidate is published at the beginning of this Gazette. Candidates are subject to the rules and regulations imposed by the Commissioner General of Examinations regarding the conduct of the examination and the issuance of results. If those rules and regulations are violated, he/she will be liable to a punishment imposed by the Commissioner General of Examinations. The decision of the Commissioner General of Examinations regarding the examination results shall be final.

(B) The issuance of an examination admission card to an applicant shall not be considered an acceptance that he or she is qualified to sit for the examination or fulfills the eligibility criteria for the post.

10. Identity of Candidates:

Candidates must prove their identity to the satisfaction of the Supervisor of the examination hall for each subject they sit for at the examination hall. Only the following documents shall be valid for this purpose.

- iii. Valid Sri Lankan Driving License

Furthermore, candidates must enter the examination hall without covering their faces so that their identity can be verified, and without covering both ears so it can be confirmed that they are not wearing any electronic communication devices. Anyone who refuses to verify their identity in this manner shall not be admitted to the examination hall. Moreover, from the moment of entering the examination hall until the conclusion of the examination and departure therefrom, they must remain without covering their faces and ears.

11. Penalty for Furnishing False Information:

Great care must be taken to provide accurate information when filling out the application. If any candidate is uncovered to be ineligible according to the rules and regulations of this examination, their candidature may be cancelled at any time—whether before, during, or after the examination. If it is revealed that an applicant

1. IT is hereby notified that an Open Competitive Examination for the recruitment of 08 Assistant Controllers of Explosives, Grade III of the Executive Service Category of the Ministry of Defence will be conducted by the Commissioner General of Examinations at examination centres established in Colombo in August 2026 only.

(a) The application form has been published on the website of the Department of Examinations of Sri Lanka, www.doenets.lk, under “Our Services” in

the section “Online Applications - Recruitment Exams / E.B. Exams”, and applications can be submitted only through the online system. The online application submission will open on 13th July 2026 at 09.00 a.m. and will close on 07th August 2026 at 09.00 p.m.

(b) Officers who are currently serving in the public service / provincial public service should submit a copy of the application to their Head of Institution for inclusion in their personal file. At the time of being called for the interview, a certified copy of the application endorsed by the Head of Institution, along with a letter confirming service, should be submitted.

(c) Any adverse consequences arising from delaying the submission of applications until the closing date shall be borne by the applicant.

2. Applicants who have fulfilled the required qualifications based on knowledge and skills, as determined by the results of a written examination conducted by the Commissioner General of Examinations, will be selected for appointment to the post.
3. (a) The effective date of appointment shall be determined by the Public Service Commission. The appointing authority has the power either to fill a certain number of vacancies or to leave all vacancies unfilled.

- (c) This appointment shall be subject to a probationary period of three (03) years. The appointee to the post of Assistant Controller of Explosives, Grade III, shall be required to pass the First Efficiency Bar Examination within three (03) years from the date of recruitment, as specified in the Scheme of Recruitment.
- (d) Appointees must also satisfy the requirements of proficiency in the official languages as stipulated in Public Administration Circular No. 18/2020 dated 16.10.2020 and the circulars incidental thereto, in accordance with the language medium under which they qualify for appointment.
4. In terms of Public Administration Circular No. 10/2025 dated 25.03.2025, the post is assigned the SL-1-2025 salary code and carries a salary scale of Rs. 82,150 – 10 x 2,400 – 8 x 2,940 – 17 x 3,900 – Rs. 195,970.  - III. Possession of a Degree in Science with

Chemistry, together with a Postgraduate Diploma in Chemistry, from a University recognized by the University Grants Commission;

or

IV. Being a Chartered Member of the Institute of Chemistry.

V. For Internal Applicants:

Being an officer of the Ministry of Defence holding a Bachelor of Science Degree with Chemistry from a University recognized by the University Grants Commission, and having completed a continuous and satisfactory period of service of five (05) years in the field of explosives under the supervision of the Controller of Explosives.

Note: The condition stipulated in (f)(V) shall apply only to officers who, as at 23 March 2012, have been serving under the Ministry of Defence as Authorized Officers in the field of explosives under the supervision of the Controller of Explosives.

It is mandatory that every applicant shall have fulfilled all the qualifications relevant to the post on or before 30 June 2026.

7. Examination Procedure

7.1 Examination Structure

I. Comprehension

This question paper consists of essay writing, precis writing and several passages prepared to

assess the candidate's grasp of language usage. Based on these passages, candidates shall be required to express the meaning of underlined words in a single sentence, write critical notes thereon, select the most appropriate statement from given alternatives, or choose the correct answer from multiple choices provided.

II. Intelligence Test

This is an objective-type question paper designed to assess the candidate's ability in logical reasoning and analytical skills, as well as the capacity to arrive at correct inferences, through problems presented in verbal, numerical, and diagrammatic contexts.

III. Practical Chemistry

This question paper has been designed to evaluate the candidate's understanding of Sri Lanka's geographical location, the distribution of its mineral resources, the chemical foundations of economic development, the composition and application of explosives, and the knowledge of amendments enacted over time under the Explosives Ordinance No. 21 of 17 February 1956, as well as under subsequent Acts No. 33 of 1969, No. 36 of 1976, No. 14 of 1978, and No. 18 of 2005.

- (b) Candidates shall obtain at least forty percent (40%) of the marks allocated for each subject to qualify for appointment through this competitive examination. Appointments will be made strictly in accordance with the order of marks obtained, ensuring that all vacancies allocated for the examination are filled.

Note: These question papers are prepared to assess the qualifications and abilities of candidates for official duties.

7.2 Release of Examination Results

The decision of the Commissioner General of Examinations regarding examination results shall be final.

7.3 Instructions regarding Online Application for the Examination

- (a) The online examination application must be completed in English only. The Department will inform whether the soft copy of the application submitted online has been accepted as a valid application or not, via SMS to the mobile number used to access the system or via the provided email address. Before completing the online application, applicants should download the instruction sheet prepared for examination applications and strictly follow those instructions when filling in the application. Any amendments made after obtaining a printed copy of the application will not be considered valid. Incomplete applications will be rejected without notice.
- (b) Candidates are required to furnish accurate and truthful information with the utmost care when completing their applications. Should it be determined, in accordance with the regulations of this examination, that any candidate is unfit to participate, their candidature may be cancelled at any point—prior to, during, or after the examination.
- (c) If it is later revealed that any information provided by a candidate is false, or if it is discovered that the candidate has willfully concealed any relevant matter, the candidate shall not be considered for appointment. Moreover, any appointment granted on the basis of such information may be revoked, and the candidate may be removed from government service.

7.4 Payment of Examination Fee

The examination fee is Rs.1,200. When paying the examination fee, payments must only be made through the following payment methods provided

by the online system:

- I. Via any bank Credit Card
- II. Via any Bank Debit Card With the Facility Of Internet Transactions
- III. Via Bank of Ceylon Online Banking system
- IV. Via any Bank of Ceylon branch

Note:

- a) Instructions as to how to make payments through the above methods have been published on the website under the technical instructions relevant to the examination.
- (b) Receipt of payment will be notified via SMS or email. The full examination fee must be paid, and applications with either underpayments or overpayments will be rejected. The Department of Examinations of Sri Lanka shall not be held responsible for any errors occurring during the payment of examination fees through the above-mentioned payment methods.
- (c) Under no circumstances shall the fee paid for the examination be refunded or transferred to any other examination.

7.5 Issuance of Admission Cards

- (a) Only candidates who have paid the prescribed examination fee on or before the closing date for submission of applications, and who have duly submitted their applications together with the relevant payment receipt, shall be issued admission cards for the examination online by the Commissioner General of Examinations, on the preliminary assumption that they meet the qualifications specified in the *Gazette* notification. Candidates will be informed of the issuance of admission cards through a notice published on the official website of the Department of Examinations, Sri Lanka, as well as via SMS.
- (b) A candidate who does not receive the admission card shall make an inquiry with the Institutional Examinations Organization Branch of the Department of Examinations, Sri Lanka, in the manner specified in the relevant notice. When making such an inquiry, it would be more effective if the candidate correctly states the name of the examination applied for, his or her full name, National Identity Card number, and address. For the purpose of verifying the information required by the

Department of Examinations, it would also be useful for the candidate to have at hand a copy of the application submitted, together with the receipt issued for payment of the examination fee, at the time of inquiry.

- (c) If any corrections are found necessary upon verification of the admission card, the Department of Examinations must be contacted to make the required amendments in accordance with the application. Requests for corrections made at the examination hall or during the interview will not be entertained.
- (d) The admission card for the examination shall bear the certified signature of the candidate. A candidate applying through a government institution shall obtain the required certification from the Head of that Institution or from an officer duly authorized by him. Candidates applying otherwise shall obtain certification from one of the following: the Principal of a Government School, a retired public officer, the Grama Niladhari of the division, a Justice of the Peace, a Commissioner for Oaths, an Attorney-at-Law, a Notary Public, a commissioned officer of the Armed Forces, an officer in the permanent staff grade of the Government or Provincial Public Service, or the Chief Incumbent/Head Priest of a Buddhist Temple, or a person of recognized standing at a place of worship of another religion.

7.6 Admission to the Examination

- (a) The admission card containing the certified signature of the candidate shall be submitted to the Supervisor of the Examination Centre on the day of the examination. No candidate who fails to produce such an admission card will be permitted to sit for the examination.
- (b) Each candidate is required to sit for the examination at the examination hall assigned to him. The set of rules to be followed by all candidates is published at the beginning of this *Gazette* notification.

Note: The issuance of an admission card to a candidate does not imply that the applicant meets the qualifications

required to sit for the examination.

- (c) Candidates appearing for the examination must prove their identity to the satisfaction of the Supervisor of the Examination Centre for every subject they appear for within the examination hall. Any of the following documents will be valid for this purpose.
- I. National Identity Card
 - II. Valid Passport
 - III. Valid Sri Lankan Driving Licence
- (d) To properly verify their identity, candidates must enter the examination hall with their faces and ears uncovered, and without any electronic communication devices. If a candidate refuses to undergo this identity verification, they won't be permitted to enter the hall. Throughout the entire examination, from the moment they enter until they leave, candidates are required to keep their faces and ears uncovered.

8. In the event of any inconsistency between the Sinhala, Tamil, and English texts of this *Gazette* notification, the Sinhala text shall prevail.
9. In respect of any matter not provided for in this notification, or regarding the number of candidates to be recruited through the examination, a decision shall be made by the Public Service Commission, and such decision shall be final.

1.0 All the institutional activities such as payment of salaries, promotion of Grades and efficiency bar examinations of the officers belonging to the above services are carried out in accordance with the provisions of the Service Minute of Sri Lanka Teachers Service published in the Extraordinary *Gazette* Notification No. 1885/38 dated 23.10.2014 Accordingly, in accordance with the provisions of the third Amendment to the Service Minute of Sri Lanka Teachers' Service published in the Extraordinary *Gazette* Notification of the Democratic Socialist Republic of Sri Lanka No. 2444/21 dated 08.07.2025 and the fourth Amendment to the Service Minute of the Sri Lanka Teachers' Service published in the Extraordinary *Gazette* Notification of the Democratic Socialist Republic of Sri Lanka No. 2493/61 dated 19.06.2026, the Sri Lanka Department of Examinations has announced the holding of the Efficiency Bar Examination-I in the month of September 2026 and it is also hereby announced that the opportunity shall also be made for Parivenacharyas serving in Pirivenas, teachers with approved appointments in Government-approved private schools, and teachers with approved appointments in Assisted special schools to be seated for the above examination. Further, it is hereby announced that this examination shall be held only at the examination centres established in the cities mentioned in Schedule I and no change of the city/cities applied for shall be allowed later. In case of a sufficient number of candidates have not applied for the establishment of an examination centre in any city, those candidates shall be directed to an examination centre established in the city indicated as their second preference or to an examination centre established in another city nearby. Further, in case of a sufficient number of candidates have not applied for the establishment of examination centres in all or more of the proposed cities, arrangements shall be made to hold the examination in Colombo only by the Commissioner General of Examinations.

Applications are published and available on the website of www.doents.lk of Department of Examinations, Sri Lanka under the "Our Services" and under "Online Applications – Recruitment". Exams /EB Exams" and

applications can be submitted via online only. The online application process shall open on 13th of July 2026 at 09.00 am and shall close on 31st of July 2026 at 09.00 pm. After submitting the application online, download it and obtain two (02) printed copies thereof, filling up in the relevant parts of the two copies in handwriting, attest the applicant's signature, and include one copy in his/her personal file along with the certification of the Zonal Director of Education. The other copy should be retained in his/her possession for submission whenever necessary.

Any adverse consequences arising from delaying the submission of applications until the closing date should be borne by the applicant him/her self.

- I. Examination candidates are subject to the rules and regulations set by the Commissioner General of Examinations in relation to the conduct of this examination and the release of results.

4.0 Submission of applications to the Department of Examinations, Sri Lanka. :-

The online examination application form must be completed in English only. The Department will notify the applicant that the soft copy submitted online is accepted/not accepted as a valid application by sending

a short message (SMS) to the mobile phone number used to access the system or by sending an e-mail to the e-mail address. Before completing the online application, download the instructions for applying for the examination. Follow the instructions carefully while the application form is filled. Any amendment made to the application form after obtaining a printed copy shall not be considered as a valid amendment. Incomplete applications shall be rejected without a prior notice.

5.0 Examination candidate/ Candidates must prove their identity to the satisfaction of the officer in charge of the Examination Hall for each subject they appear for in the examination hall. Only the following documents are valid for this purpose.

- I. National Identity Card
- II. Valid passport
- III. Valid Sri Lankan driving license

Further, candidates must also enter to the examination hall without covering their faces as to verify their identity and without covering their ears as to be confirmed that they are not wearing electronic communication devices. Candidates who do not agree to this shall not be admitted to the examination hall. Further, from the moment you enter in to the examination hall and up until the examination is over and left the hall, you must be remained without covering your face or hands.

6.0 Admission cards shall be issued by the Commissioner General of Examinations via online only to candidates who have submitted completed applications correctly on or before the closing date for applications, based on the presumption that only those who have met the qualifications stated in the Gazette notification, have applied for this examination.

11.0 The examination shall be conducted in Sinhala, Tamil and English medium only. following 13.2 published in the official website of e- thaksalawa, by the Ministry in charge of the subject of Education. The written test for this Efficiency Bar shall be conducted as follows as to be covered all of those relevant modules.

14.0 Issuance of Examination Results : - The procedure for issuing examination results is as follows.

- I. The Commissioner General of Examinations forwards two copies of the results of all candidates who have been seated for the examination, separately in terms of the province, to the Secretary of the Ministry of Education, Higher Education and Vocational Education .

In order to confirm any information requested by the Department of Examinations during such inquiry, it would be advisory to have a photocopy of the completed application. If any amendments are required after checking the admission card, the Department of Examinations should be contacted in advance and the relevant amendments should be made as per the application. Requests for amendments made in the examination hall/interview will not be considered.

VI. The candidate's signature on the admission card for the examination shall be attested and candidates shall submit their signed admission card to the examination supervisor on the first day of appearing for the examination.

VII. The Commissioner General of Examinations has the power to postpone or cancel the examination with the approval of the Public Service Commission.

VIII. Candidates are subject to the rules and regulations imposed by the Commissioner General of Examinations regarding the conduct of the examination. If he/she violates such rules and regulations, he/she will be liable to a penalty imposed by the Commissioner General of Examinations.

Candidate's Identity: Every candidate should prove his/her identity in the examination hall to the satisfaction of the Supervisor. Only one of the following forms of identity will be accepted for this purpose.

- I. National Identity Card
- II. Valid Passport
- III. Valid Sri Lankan Driving License

The candidates should expose their identity without covering their face and ears when enter into the examination hall so as to verify that electronic communication devices are not being worn. Applicants who refuse to do so will not be allowed inside the examination hall. Further, the candidates should remain uncovered of their face and ears till they leave the examination hall enabling the examination authorities to identify the applicant.

in a formal form (stating that the names in the relevant certificates are different and that the names refer to the same person, and your signature on an uncanceled stamp of Rs. 50/- should be attested by a Justice of the Peace or a Commissioner of Oaths) should be submitted to explain the difference.

- f) Certificates of professional Qualifications (If any)
- g) Certificate of highest examination passed in Sinhala/Tamil/English languages.

II. If a candidate is found to be ineligible, his/her candidature may be cancelled at any time before, during or after the examination. If any fact presented is revealed to be false after being selected for a position, or if any important fact is deliberately suppressed, there is a possibility of dismissal.

09. Interview

I. Candidates selected through the written test should present the following documents at the interview.

- a) Birth Certificate
- b) National Identity Card or Valid Passport
- c) Degrees (degree certificate and detailed degree certificate) and other relevant educational certificates
- d) 02 character certificates (one of these certificates should be a certificate issued by the Grama Niladhari and not more than 06 months old)
- e) If there is a slight difference between the name you use and the name mentioned on your birth certificate or other certificate, an affidavit

10. The decision of the Public Service Commission shall be final in respect of any other matters not included in this notice calling for applications and relating to this recruitment.

11. In the event of any inconsistency between the language versions of this notification published in Sinhala, Tamil and English, the Sinhala text will be considered as correct.
